## Supporters push Annual Fund past 1990-91 goal

Annual Fund Director Chris Becker has announced that Grace has exceeded its Annual Fund goal of \$1.12 million for the 1990-1991

fiscal year. "It's all due to God's grace and the faithful prayers and gifts of the alumni and friends of Grace College and Seminary," Becker said.

The Annual Fund is a crucial component of the college and seminary budget each year. Among other things, it provides student scholarships, financial aid, faculty salaries and development, campus improvements, and student services.

This fiscal year's Annual Fund total of \$1,129,112 is the largest the institution has received, except for the 1987-1988 fiscal year, when an unusually large estate gift boosted the fund total, Becker explained.

"It is remarkable," he added, "that most of the gifts to the Annual Fund come from thousands of ordinary people across the country. Except for one large annual grant from the Andersen Foundation, most of the gifts Grace receives are modest amounts, representing widespread support throughout the nation."

Becker added that the average annual giving from each donor is about \$250. "Many people give less, and some give more, but each donor can rejoice that God has used each of them to help exceed the goal."

At the beginning of the 1990 fall semester, the institution's administration anticipated a budget deficit of more than \$700,000. Donors' generosity in giving to the Annual Fund helped to reduce that deficit, which is now expected to be below \$200,000.

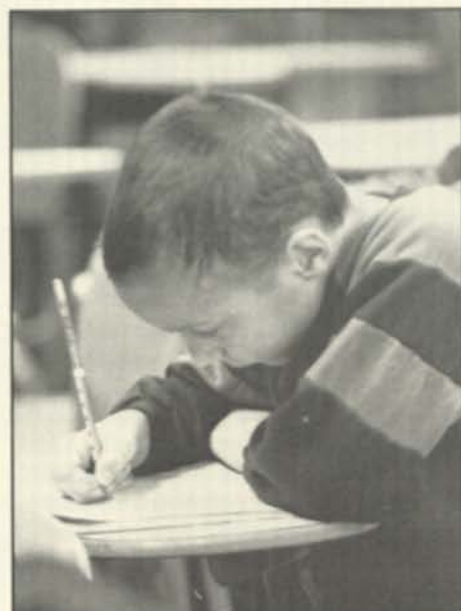

## 'Chouette' students find language study can be neat

Once again this year, the "Chouette Children's Language Program" led by Dr. James Nesbitt, Chairman of the Department of Modern Languages at Grace College, has nationally recognized award winning students participating.

Started in 1981, Chouette (the word means "neat" in French) is based on the theory that the prime time for learning a second language is between the ages of 6 and 12. Each week students meet for one hour in the lower level of Morgan Library to learn French. They are in-

structed by Dr. Nesbitt, Miriam Aellig, Denise O'Daniels, and Eric Nesbitt.

This past February, 17 Chouette students were among the 80,000 who competed in the National French Contest sponsored by the American Association of Teachers of French. The contest measures the students' proficiency in vocabulary, grammar, culture and civilization, and sound discrimination.

Winners in the Northwest Indiana Region Division A are the following Chouette students: Carrie Nesbitt, 1st; Baruch Zobrist, 4th; Julie Mayer, 5th.

Northwest Indiana Region Division B: Tiffany Parter, 1st; Benjamin Porter, 2nd; Kimberly Buhlmann, 3rd.

Benjamin Porter also placed 5th nationally. Baruch Zobrist, Yochanan Zobrist, and Yoram Zobrist were all awarded National Honorable Mention.

## Faculty news and appointments

The Grace College and Seminary Board of Trustees has recently announced several new appointments.

Dr. Peter Gano, Columbus, Ohio, is taking an early retirement from Ohio State University's School of Music and will serve as Adjunct Professor of Fine Arts at Grace College. Dr. Gano will teach the Fine Arts Appreciation courses along with courses in Music History and Music Literature.

He received his Ph.D. in Historical Musicology from the University of California, Santa Barbara, and did his graduate and undergraduate studies in music and music education at Pennsylvania State University.

Dr. Gano has had extensive professional music experience, as well as contributing significantly to educational curriculum development. He has been a faculty member at the Ohio State University's School of Music since 1968 and has served as Chairman of the Division of Music History and Literature since 1985.

Dennis E. Gaerte, Roanoke, Virginia, will serve in the Education Department,

both as instructor of education courses and as director for student field experiences, particularly for placement and evaluation of student teachers.

Prof. Gaerte received his B.A. degree in German and his M.S. degree in Education from Indiana University. He has completed post-graduate work to obtain his license in secondary school administration. Currently serving as High School Principal at Roanoke Valley Christian School, Prof. Gaerte has had administrative experience in several Christian schools, founding one in his home church.

Prof. Roger Peugh, former Grace Brethren missionary to Europe and FGBC European Regional Director, will assume responsibilities as Chaplain for Grace College. He will continue his position as Director of the Graduate School of Missions at Grace Seminary.

Paul Bowman, part-time Spanish instructor at Grace College, will serve as Coordinator for the Modern Languages Department during the 1991-92 academic year. He graduated from Grace College with a Spanish and Biblical Studies degree in 1990 and is currently a student at Grace Seminary.

Dr. Darrell Johnson, Associate Professor of Physical Education, recently completed his Ph.D. degree in physical education at the University of Alabama.

## Over \$1,500,000 given in financial aid

Last year at Grace, students received well over \$1,500,000 in financial assistance, according to Steven Petty, Director of Student Financial Aid Services. Up to 94 percent of Grace College students received aid.

Scholarships, grants and work study programs are funded by Grace College and Seminary, by the state and federal governments and through outside programs.

Students who excel academically may have up to 50 percent of their tuition covered by scholarships such as the Presidential Merit Award or the Leadership Merit Award. Over 70 students received these scholarships in the 1990-91 school year.

Leadership in church, high school and community activities, along with spiritual maturity, are qualities considered for the Leadership Merit Award. A recommendation and a personal interview are required. Minimum standards include a high school GPA of 2.5, an ACT composite score of 22 or a class ranking in the top 25 percent.

The Presidential Merit Award requires an essay and a personal interview. Minimum standards include a high school GPA of 3.85, an ACT composite score of 27 or a class ranking in the top 10 percent.

Similar academic standards are necessary for the Alva J. McClain Scholarship; however, no personal interview or essay is required.

Students with exceptional abilities in athletics, fine arts, drama or speech may qualify for the Talent Awards. Over 85 students received Talent Awards in the 1990-91 school year.

## Rev. Tom Hammers Passes Away

A memorial service was held March 31 at the Winona Lake Grace Brethren Church for Rev. Thomas E. Hammers, who died March 27, 1991. He was associated with the ministry of Grace College and Grace Theological Seminary for several decades and was one of the 18 people who met at the late Dr. J.C. Beal's home in Ashland, Ohio, in June 1937 at the prayer meeting that led to the establishment of Grace Theological Seminary.

Rev. Hammers was born April 6, 1903, in Johnstown, Pennsylvania. He graduated from Ashland College, Ashland, Ohio, in 1932 and earned a Bachelor of Divinity degree from Ashland Theological Seminary in 1935. He started the First Brethren Church in Cleveland under the Brethren Home Missions Council. In June 1935, he moved to Cleveland as the Church's full-time pastor. He also served in two California



churches in the 1940s, established a church in Seattle, Washington, in 1952, and was called to pastor the Grace Brethren Church in Fremont, Ohio, in 1959.

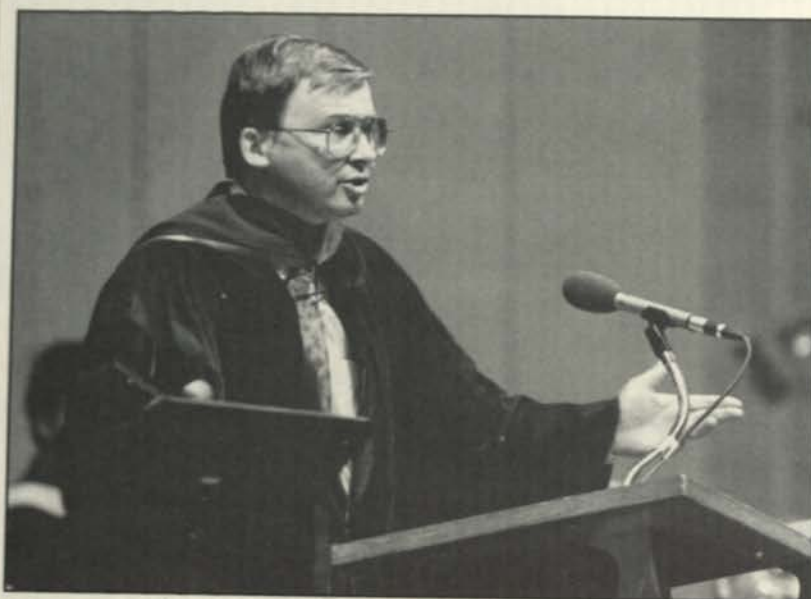
After 30 years of Christian service including five pastorates, at the age of 61 Rev. Hammers and his wife, Mary, moved to Winona Lake, Indiana, where he helped to start the newly organized Development Department at Grace College and Seminary. As Alumni Coordinator, he helped to organize many alumni functions and published campus news and alumni information in the *Alumnews*. He traveled countless miles representing Grace and pioneered many new programs for those who had received their education at Grace.

Hammers was honored nationally by being included in the 1969 edition of *Who's Who in American College and University Administration*.

Following his retirement at the age of 72, he developed and directed the Living Memorial Gift Program at Grace College and Seminary for three years on a part-time basis. In 1979 he was named "Grace Theological Seminary Alumnus of the Year."

From 1975 to 1983, Rev. Hammers was Visitation Pastor for the Winona Lake Grace Brethren Church. He also served on the Board of Trustees for the Brethren Missionary Herald Corporation from 1940 to 1982.

### Career development assistance expands

Doug Wilcoxson, Director of Career Development at Grace College, continues to expand career development opportunities and assistance to meet the challenge of preparing students for work experiences after graduation.

"We are focusing on the need to implement programs that make it possible for students to move from the classroom to their chosen work place successfully. It's the old analogy of giving a man a fish and feeding him for one day or teaching him to fish and feeding him for a lifetime," Wilcoxson says.

This practical approach is foundational to everything considered and utilized by the department. Currently, Wilcoxson is developing a hierarchy of priorities to guide them.

First is the creation of a comprehensive education program designed to help students from the time they apply until graduation. Specific schedules of contact points will be created and adhered to. Each student participates in personal assessments and goal setting designed to keep him or her directed and to identify areas where help is

needed. For each student, these become more specific as graduation approaches and decisions are made directly relating to career plans.

The second priority is the expansion of the network of employers in Indiana and surrounding states who are already available. "We want to be more aware of the real staffing needs in the work place and provide students with

actual facts and the information they need," he explains.

Another priority is strengthening relationships with all alumni and friends of Grace College. Often one of the main blocks in a student's ability to succeed is an unwillingness to be flexible geographically, according to Wilcoxson. "We want to make it possible for recent graduates to have contacts for information and realistic guidance as they consider moving to a different location or entering a certain profession. Such contacts could supply specifics about the area, such as industry forecasts, economic stability, housing costs, as well as information about schools and churches. This helps students to overcome the barrier of the 'unknown'."

Wilcoxson also says it is vital to develop and maintain cooperative arrangements with regional employers as a means of creating opportunities for internships or other actual work experiences in several fields. These make it possible for the students to make informed decisions about their real future possibilities and chances of ultimate success.

"We are addressing the reality that students must be prepared for success and guided toward it," Wilcoxson states.



## Campus Life magazine offers scholarships

In recognition of the achievements of graduating high school seniors, Grace College is funding *Campus Life* magazine scholarships for three students enrolled for the 1991 fall semester.

Those chosen were Kerry Byers, daughter of Dr. and Mrs. Don Byers, Warsaw, Indiana; Amy Miller, daughter of Mr. and Mrs. Tom Miller, Warsaw, Indiana; and Dave Pacheco, son of Mr. and Mrs. Dan Pacheco, Winona Lake, Indiana.

Winners are selected by the staff of *Campus Life* magazine and their local church youth leaders, based on a written essay and involvement in church, community, and school. The students also had to meet basic minimum requirements - class rank: top 20%; grade point average: 3.0 (4.0 scale); and SAT score of 1000 or ACT score of 23.

Each student will receive \$500 per year for four years.

Grace is one of 104 Christian colleges currently participating in this *Campus Life* scholarship awards program.

## Rick Gorrell earns public service award

Rick Gorrell, a junior math major from Berne, Indiana, recently earned an award for outstanding public service from the Indiana Conference Compact, an organization promoting public service opportunities for college students. Rick and students from 26 other Indiana colleges and universities were honored at a luncheon at the Radisson Plaza in Indianapolis. Dr. John J. Davis introduced Rick at the luncheon.

"Members from the Compact came to campus," Rick explains, "and asked students and faculty, 'Who at Grace is most actively involved in community service?' I guess my name came up most often."

During his three years at Grace College, Rick has been active in the Light-house ministry as a "big brother" to a community child. He served as co-chairman of "Heart of the Holidays" this year, an annual Christmas community

You would recognize a name in the upcoming edition of the *Journal of the Evangelical Theological Society*. That is because it is one of Grace's own - Dr. Ted Hildebrandt, Professor of Biblical Studies at Grace College.

Dr. Hildebrandt presented a paper on "Motivation and Antithetic Parallelism in the Proverbs" at the national meeting of the Evangelical Theological Society in New Orleans last fall. It was after hearing Hildebrandt's presentation that Dr. Ronald Youngblood, who currently is working on the *Word Commentary of Proverbs*, agreed to publish the paper in the *ETS Journal*.

Composed of evangelical scholars, ETS attracts Christian educators from well-known Christian colleges and graduate schools, including Grace College and Grace Theological Seminary. Up to 470 Bible teachers and leaders attend the ETS meetings.

Dr. Ron Clutter, Professor of Theology and Church History at Grace Seminary calls it, "the leading scholarly organization for evangelicals." In the past, ETS attracted Christian leaders such as Carl Henry and Francis Shaeffer to its ranks. Dr. Clutter and Dr. John Davis presented papers at previous national meetings, while several faculty members have participated in regional meetings.

"ETS is directed at evangelical leaders," says Dr. Hildebrandt. "I guess one of the reasons why I love going there is because it gets me into a different environment, one where my peers are really going after an understanding of the Bible, addressing the real issues facing evangelicals at the end of the twentieth century. I need that kind of revitalization."

A specialist in wisdom literature, Hildebrandt had been doing research on motivation in the Proverbs for more than a year. One Sunday, he recalls, the idea for his proposal came to him unexpectedly. He explains: "All of a sudden I got this bright idea. It was a totally different way of looking at motivation than



previous Old Testament studies." Pursuing that bright idea, Hildebrandt explored the Proverbs for the next several months looking for "unmarked motives." "When I discovered them everywhere," he says, "I knew that I had found something legitimate."

The response at ETS was enthusiastic. "Since this approach is very novel, I was ready for criticism," says Hildebrandt. "In fact, I allowed ten minutes at the end of my presentation for comments. But everyone was very positive, including a former seminary professor of mine and Dr. Youngblood."

"My original goal," says Hildebrandt, "was to work with this notion of the father as a motivator. I'd like to write a book on fathering, but I don't think I can write on the popular level unless I am credible on the scholarly level. I've got to be sure that I 'know my stuff' first."

"Motives of the heart are a critical area of concern for fathers; for everyone seeking to please our heavenly father. Proverbs 16:2 says that motives are weighed by the Lord. So it's not just what we do, but why we do what we do that counts. That's where I've got to help my children realize God's grace."

More recently, Dr. Hildebrandt completed editing the Old Testament section of Josh McDowell's one-volume survey of the Bible. "Tyndale House is the publisher. They wanted me to proofread it and bring it up to date in terms of recent Old Testament studies," he explains. Because of his specialty in the Proverbs, Hildebrandt also helped with the new revision of the Living Bible, working to "make it more accurate and still retain readability."

## Grace College earns Templeton honors

Grace College is one of 49 schools receiving honorable mention for the John Templeton Foundation Honor Roll for Character Building Colleges in 1991.

The Honor Roll, sponsored by John Marks Templeton and the John Templeton Foundation, is an annual listing of schools which "best exemplify campuses that encourage the development of strong moral character among students."

Although many colleges and universities today have taken the position that responsibility for character development and moral value judgement lies outside the realm of academia, the Templeton Foundation has chosen to recognize schools such as Grace College that strive to build students with character as well as intellect, a sense of morality as well as an ability to reason.

The listing of schools was compiled by polling college and university presidents and directors of development of four year accredited institutions of higher education across the country.

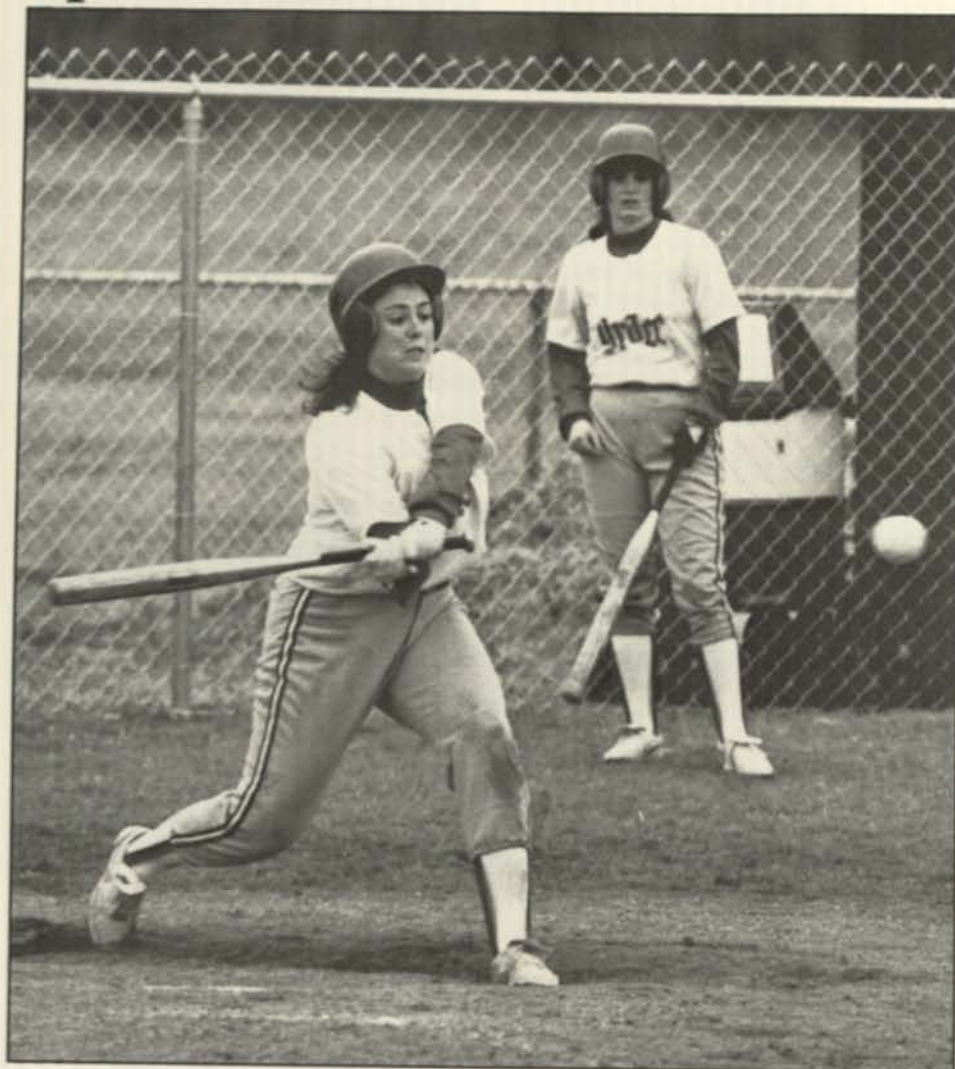

first time in the college's history. In that tourney, sophomore Matt Dick turned in a season-best 72.

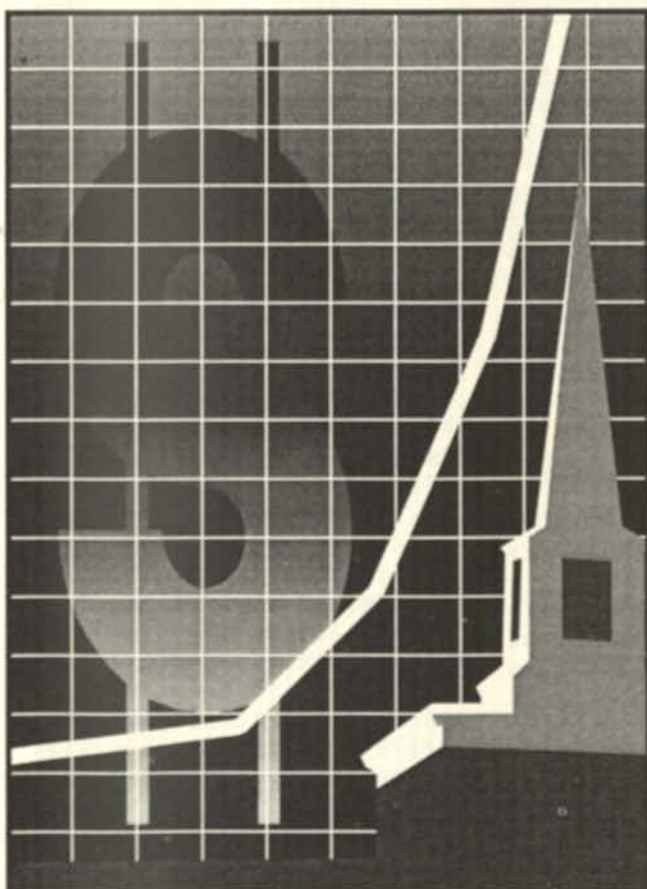

# The Grace Experience

*Each spring is a time of 'farewells' on the campus of Grace College and Grace Theological Seminary, as some students graduate and others go home until their return for fall classes. This year, there are some additional farewells.*

*Three long-time faculty members are retiring, and a fourth is leaving to take charge of a mission agency. Since they have meant so much to what 'The Grace Experience' really is, these pages are about them and dedicated to their ministries.*

## Prof. Jean Coverstone

Associate Professor of Art Jean Coverstone had a dream as a high school student. She wanted to become a concert pianist. Her love for music and hours of practice pushed her along.

But almost overnight her dream was shattered. Like many others in the early 1950s, she contracted polio. After being able to play arpeggios and trills effortlessly, suddenly she found herself unable to do even the simplest tasks requiring her hands. So her physician suggested working with clay to restore their use.

After some time, she and her husband Dean, a ceramist, opened a ceramics hobby shop. It was then that she began thinking of pursuing art seriously. "I just felt my lack of background and knowledge. I had always wanted to teach, and, since music performance seemed to be out of the picture, art looked like the direction to pursue." Prof. Coverstone remembers.

The Coverstones had a family conference. "My kids were all teenagers by that time, and they said, 'Mom, you're getting old. If you're ever going to be a teacher, you'd better get at it.'" And so, at age 38, Jean Coverstone enrolled in college as an art education major.

When she first heard about the opening for an art faculty member at Grace College, she admits, she did not think there was much point in applying. "I didn't have my master's degree completed at that time, and I'm not Grace Brethren," she smiles, "but after seeing the art facility (a basement room in what is now the Omega Center), I very quickly reasoned that no self-respecting man would consider it."

Accepting the challenge, Prof. Coverstone came to Grace College in 1970 to teach art. During her career, the art program has grown from that early basement room to a large department with 50 art majors. The department offers students not only traditional art instruction, but also the latest in computer graphic design. The department is plan-

ning a major expansion of its present facility in order to accommodate more students.

But it is not just the progress in numbers and size that impresses Prof. Coverstone. It is the people and the atmosphere at Grace College, an atmosphere which has given her the right to integrate her faith and biblical truth into her teaching. "I've done a little teaching in some universities. The money is great, but it just never was right to go into class and not ask for prayer requests or share things like that."

"My philosophy has always been to teach what meets the needs of the students, not necessarily what I want to teach. Our program seemed to grow that way." As the young Art Department grew toward offering students the opportunity to major or minor in art, Prof. Coverstone completed her graduate work at Notre Dame University. She added art history courses to the curriculum for the new art minor and, later, laboratory courses in drawing, painting, and design, finally enabling the art major to become a reality.

Shaking her head, she acknowledges that computer graphic design, the newest art major field (and fastest-growing major at Grace College), is simply not her field. "My mind doesn't absorb that kind of technology," she says. Prof. Art Davis heads those courses.

As the art program grew, the facilities expanded from the basement of Omega, to North Hall (which no longer exists), then to Sands Hall, and finally to the present facility in Colonial Hall. With all of the expansions and need for classroom space, as well as the place for art appreciation classes in every Grace College student's general education, Prof. Coverstone holds what may be a distinction among Grace College faculty: she says she has taught in every building on the Grace College campus, except for Lancer Gymnasium.

She and Prof. Art Davis have worked together very closely in recent years on plans for an addition to Colonial

Hall. "We're just praying that the finances will come through so that the new Art Center at the college will be a reality."

For all her teaching career, Prof. Coverstone's love for her students has been obvious. She comments, "The young people have been exciting because they're so genuine. I see them want to develop their art abilities in the right way, trying to better themselves and their world and ultimately for the glory of God. I can't think of anything that's been more rewarding."

In her classes, she tells her students, "You have to know the rules before you can break them." She says, "We always try to teach them basic design or drawing, but then we never try to inhibit someone if he or she feels led to work in a particular style. Our students are so eager to do their best and to make something exciting. Maybe it is something entirely new or something in a new direction."

At the same time, Mrs. Coverstone challenges her students to consider whether the world will be a better place because of their efforts. "There is certainly room for Christian artists in the world. We're so visual. In our art classes,

we talk through modern trends in art and where some of it has gone and is going. I encourage them to lift art from some of the morasses it has fallen into."

Known affectionately as "Mrs. C" to most students, Prof. Coverstone tries to keep track of her art alumni. She sends Christmas cards and attempts to remember the new babies. The Art Department also sends a newsletter to art alumni. Nearly 80 percent of Grace art alumni currently are in art-related careers, a remarkable record for any college or university in the preparation of students for practical and productive careers. It is also a higher percentage than some well-known art institutes can claim.

At Grace College, art is not an easy program either, she asserts. "Anyone in art at Grace could tell you that it is demanding. When graduates leave here they have a professional-type portfolio if they are in graphic arts. Art education majors leave with the kind of experiences that qualify them to teach

almost anywhere."

Her love for art history has led her to Europe - eight times. One semester, Prof. Coverstone took a sabbatical, during which she and her husband travelled on their Eurail passes for four months, collecting photos and valuable information for the art appreciation textbook Prof. Coverstone produced.

Travelling is something she and her husband hope to do in retirement. "But right now," she says, "my 96-year-old mother is a top priority. We want her with us just as long as we can give her the kind of care she needs." Prof. Coverstone plans to spend more time in her husband's pottery shop, Dean's Dungeon, in North Webster, Indiana.

Looking ahead to her retirement, after 21 years at Grace College, Prof. Coverstone says, "I feel good about leaving the department where it is; I feel good about where it's headed. It's time that we get new blood and new ideas in here."

With a smile she adds, "When I first came, students would say, 'You remind me of my mother.' Now they say, 'You remind me of my grandmother.' So I think it's time to get out of here."

## Dr. Jesse Humberd

A typical middle of the afternoon. The only sounds disturbing the silence in Sc327 are the muffled ticking of a pendulum clock and the staccato of typewriter keys. Facing narrow floor-to-ceiling windows, Dr. Jesse Humberd types a test on a ditto master. Perhaps his thousandth. To his back is a bookshelf-filled wall, crammed with volumes on geometry, chemistry, teaching methods, philosophy of education, and theories of mathematics, some yellowed and dusty, others boasting shiny new covers. On the other side of the office, his father's early 20th-century roll-top desk shares the wall with a new computer. The old with the new—covering a span of 37 years. That kind of diversity characterizes Dr. Humberd's teaching career at Grace College.

Professor of Science and Mathematics Dr. Jesse Humberd began teaching at Grace College when the college was established as a four-year school in 1954. "I graduated from Grace Seminary in 1954," he says. "That fall, Dr. McClain and Dr. Hoyt wanted to start the four-year undergraduate program. So I came on as head of the Math and Science Department. That's when Prof. Wayne Snider came to head the History Department and Prof. Don Ogden came as chairman of the Music Department."

Dr. Humberd's undergraduate studies at Bryan College and Wittenberg College, along with his masters degree work at Ohio State University, prepared him to teach math and science. But he soon found himself doing much more. "I really have been a jack-of-all-trades," he stresses. "I never had time to concentrate or specialize in something. When a school is small and growing, one needs to go in a lot of different directions."

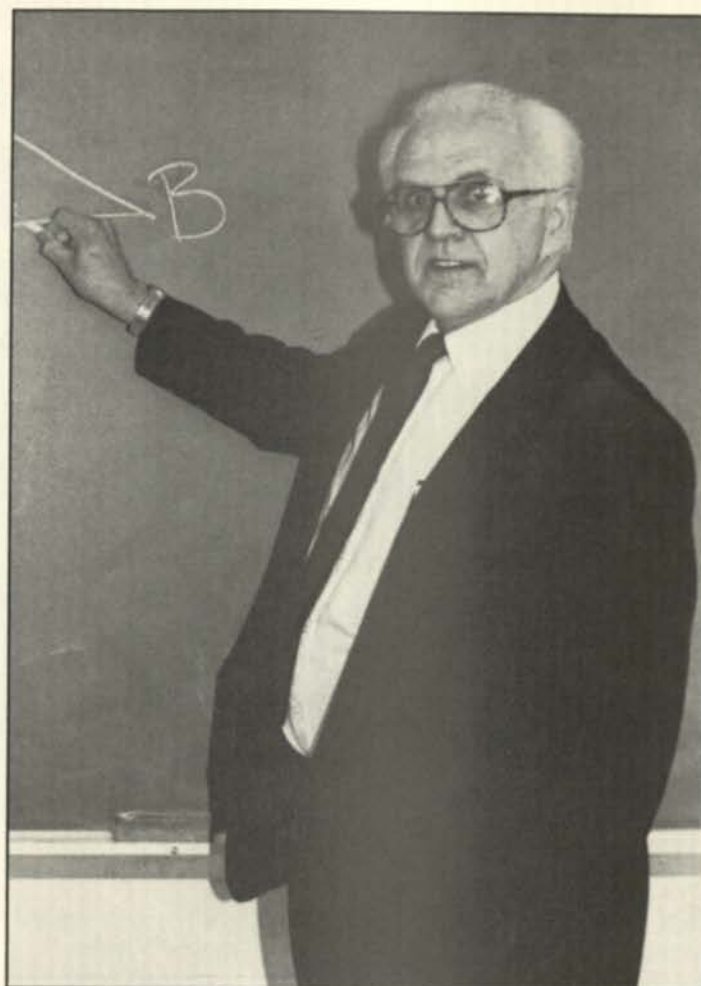
For Dr. Humberd, that has meant teaching more than 40 different courses, from calculus to geography. He says, "Every time the college got larger, I introduced another course."

Besides flexibility in teaching, he has had a lot of extra involvement at Grace. One early school catalog records Dr. Humberd's participation on six different committees. He has been on the Teacher Education Committee since his first year at Grace.

Sometimes Dr. Humberd's teaching required a lot of ingenuity, due to the growing pains of a new college. For example, one semester he had to teach advanced algebra via television—at 6:30 a.m. He taught his first science courses in what is currently the Omega Center. "That building had a kitchen and it was the only place on campus where I had running water available," he says. When chemistry was added to the curriculum, Dr. Humberd and his students drove to Warsaw High School. "The Warsaw superintendent let us have the chemistry lab Monday afternoons" he recalls. "They had all the glassware and chemicals that we needed."

And then there was summer school. For 18 years, Dr. Humberd was the person in charge. In the early days, he scheduled the courses, hired the teachers, and determined salaries and tuition fees.

Before Dr. Humberd came to Grace Seminary, he taught for three years in a small country high school and one year at Wittenberg College. "I was the only one with public school experience when the college began, so I got involved in the teacher education program at Grace right from the start."

But maintaining credentials to train future teachers demanded extra effort. So Dr. Humberd went back to school. He earned his doctorate at Ohio State University by attending summer classes. During the 1958-59 school year, he and his family moved to Columbus, Ohio, so he could complete his residency. That year he taught at the Ohio State University High School as well as in the university's math department.

With a modest smile, Dr. Humberd says that after looking through past grade books, he has counted over 510 student teachers whom he observed and evaluated. That has given him a lot of satisfaction.

Dr. Humberd has a lot of confidence in the math program at Grace College, too. "Maintaining a strong math program is unusual for many Christian schools," he says, "but we have produced many top-quality math majors, particularly math teachers."

His most visible, and perhaps one of the hardest-won achievements is the Cooley Science Center. Dr. Humberd muses, "I have a drop of blood in every brick of this building." It was not easy to finance a building project back in the late '70s. The economy was poor, but something needed to be done." Dr. Humberd had helped to hire six new faculty members to teach math and science. Prior to the construction

of the Cooley Science Center, all six of the new math and science faculty members were sharing two or three classrooms in Philathea Hall. It was a top-quality faculty - all six of the new faculty held doctorates - and Dr. Humbert feared he would lose them if something did not happen. (Three of them are still with Grace. They are Dr. Richard Dilling, Dr. Don DeYoung, and Dr. Richard Jeffries.)

Dr. Humbert's dream came true in the fall of 1977 when the department moved into the modern, three-story Cooley Science Center.

Dr. Humbert's active involvement in education and in Grace College seems to have rubbed off on his family. A photograph on the wall of his office shows him, his wife, their two daughters, and two sons-in-law. All are wearing Grace graduation gowns for the photo, because they all are Grace graduates. In addition, of the Humberts' four grandchildren, three are at Grace College now.

After his wife Laura received her master's degree from St. Francis College in elementary education, she taught some of the elementary education courses at Grace. But she preferred teaching in the elementary schools, something she did for 30 years. Both of Humberts' daughters teach now. He says, "I guess because of our involvement in education, our family always assumed everyone went on to college."

With a diverse teaching career and a full life behind him, retirement will seem strange to Dr. Humbert. But he is not going to cut ties completely. He will be back at Grace College in the fall, chalk in hand. It's just that this time around, it will be part-time.

## Dr. Homer Kent

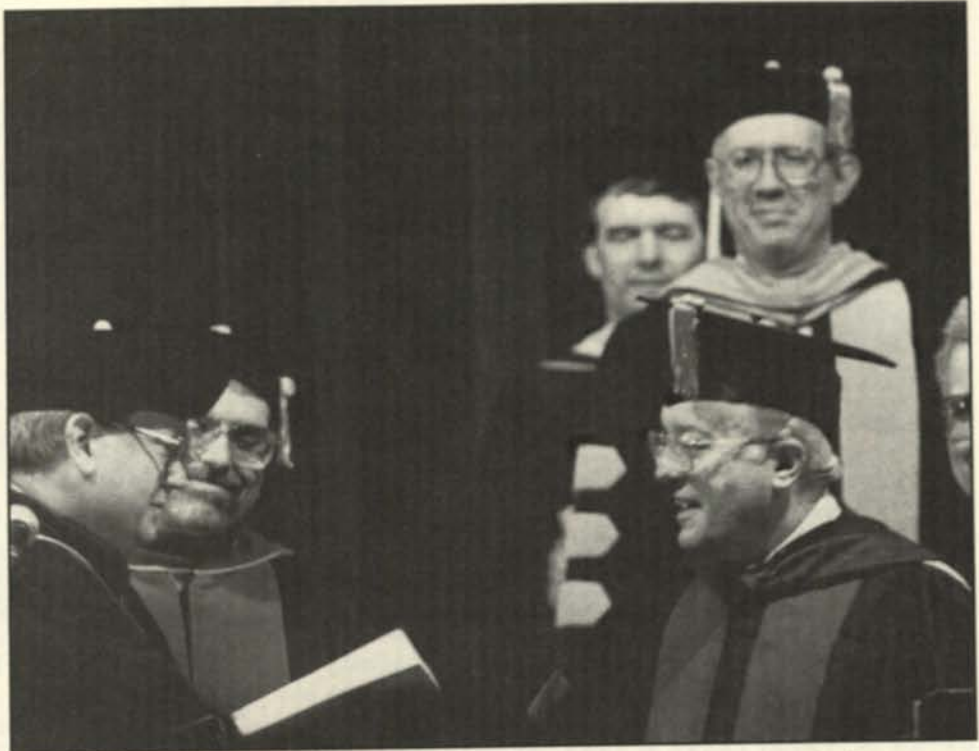

Dr. Homer A. Kent Jr. retired from his position as Professor of New Testament and Greek at Grace Theological Seminary in May, marking the end of 40 years of full-time teaching and administrative duties for the college and seminary.

Dr. Kent was born in Washington, D.C., in 1926, the elder of two sons born to Homer and Alice Kent. His father was pastor of the First Brethren Church of Washington, D.C. Both home and church were just a few blocks from the nation's Capitol Building.

The two brothers, Homer and Wendell, grew up with the blessings of a Christian home and vibrant church. The Kent

family traveled frequently across the continental United States. "We always went by car and took a different route each trip, seeing national parks and historic sites whenever possible," he remembers. "We actually saw the things that other boys only read about in geography or history books. Those are some of my best memories."

In 1940, a number of changes came to the Kent family. Homer Kent Sr. accepted the offer to be a professor of church history at the young Grace Theological Seminary, which the year before had been moved from Akron, Ohio, to Winona Lake, Indiana. The Kents left the excitement of the nation's capital and a large church with many friends for the unknowns of a fledgling school located in a small mid-western town.

In those days the seminary was small and the students and faculty were a very close-knit group. Since there was not a Brethren church in Winona Lake, all the Brethren in the community attended seminary activities. The Kent home was near the campus, and many students went there to relax and have fun.

Homer Kent attended his first three years of high school at Warsaw High then transferred to Bob Jones Academy for his senior year. The draft for World War II was in effect, and he wanted the chance for at least one year in a Christian school environment before being called to serve in the military. A profession of faith in Christ in 1934 and years of study and contemplation had led him to decide, by high school graduation, that he would follow in his father's footsteps and be a preacher. He was able to continue at Bob Jones College due to a ministerial draft deferment and graduated in 1947 with his degree in religion. Then, it was back to Winona Lake and Grace Theological Seminary for further education.

While a student in the seminary, Homer Kent was asked to teach English Composition in the growing Grace collegiate division. He remembers enjoying the teaching and the feeling of achievement that came as students responded and did well.

In 1950, he finished his senior year and was awarded a bachelor of divinity degree. "All my classmates were getting ready to go out and take pastorates, but I was still a bachelor. Churches weren't pounding on my door to hire a single man right out of seminary," he says. "I wasn't sure that I was totally ready either, so I stayed in seminary, studying for a master of theology degree and continuing to teach - this time first- and second-year Greek."

Over time, one question repeatedly surfaced: "What about teaching?" "I tried to be objective, which isn't always easy," he explains, "but I felt that I did well at teaching. I had a real satisfaction that accomplishment was occurring." He was often described by students and others as a "clear explainer" and a gifted teacher. But those were the days when "full-time Christian service" meant only one of two careers - pastor or missionary.

How could a man who had dedicated his life to service and spent years of education pursuing the pastorate balance his desire to be faithful with his apparent giftedness in teaching? "As I studied church history, I looked carefully at the life of Martin Luther, a major influence for modern Christianity. Luther was not a pastor but instead an educator, a university lecturer - a teacher. I came to understand that teaching really can be the Lord's full-time work," he explains.

And teach he did. The seminary continued to grow, and President Alva McClain asked Kent to take a full-time teaching position in the New Testament Department. "I was a green-as-grass teacher when they hired me for the fall of 1951 - and I'm still here 40 years later," he says with a smile.

In August 1953, Kent married Beverly Page. Making their home in Winona Lake, they had three children, Rebecca, Cathy, and Dan. Beverly taught voice at Grace College for 25 years.

Along with teaching, Kent studied for a Doctor of Theology degree from Grace Seminary. His dissertation on the authorship problems and message of I Timothy was presented in 1956, and an expanded version that includes the books of II Timothy and Titus became *The Pastoral Epistles*, Dr. Kent's first book, published by Moody Press in 1958.

That work, as well as Dr. Kent's subsequent books and commentary contributions, are widely recognized as representative of his careful handling of Scripture and his clear explanations about it. His knowledge of the subject and heart of a teacher combine to create books designed to instruct and make clear the passages being considered.

Dr. Kent's work at Grace Seminary expanded in 1962, when he was appointed Dean of the Seminary. He maintained a reduced teaching load during that time and assumed more administrative duties.

With 1976 came another time of questions and changes. The teacher who was thoroughly enjoying his work was asked to consider the Presidency of Grace College and Grace Theological Seminary. "I love to study Scripture and to teach - to watch students progress in their understanding. I

didn't want to lose that. I told them no," he relates.

But he was asked again. This time the offer included the opportunity to continue teaching and share the administrative duties with Dr. John Davis, who was to fill the office of Executive Vice President.

In a spirit of willingness to serve where he was needed and to grow as God presented opportunities, Dr. Kent became the third President of Grace College and Theological Seminary in 1976.

For 10 years, Dr. Kent had as his goal a school where students could daily be challenged to spiritual growth; where godly life-styles would be nurtured and encouraged. During that decade there were many achievements: highest enrollment totals for both college and seminary; completions and remodeling of buildings; an expanded library; accreditation for the seminary; and growth of endowment funds.

After nearly a decade as President, Dr. Kent announced in May 1985 his intention to relinquish his position as President to go into effect at the end of the 1986 contract. He would focus on teaching again.

That brought him back to the same third-floor office in McClain Hall that he occupied in his early teaching days, and Dr. Kent resumed teaching a full class load. Along with teaching at the seminary, he worked with the Institute of Holy Land Studies in Jerusalem, Israel, leading educational trips. Dr. Kent also has taught as a guest lecturer at Grace Seminary extensions in California, France, and Africa, as well as at other seminaries.

And now, five years after returning to the classroom, change comes again.

"I plan to continue teaching part-time at Grace Seminary. I will stay on as long as the school has need for me. There are many things I can do, and I have some ideas for further books." Dr. Kent also is considering other short-term teaching opportunities.

Dr. Kent says he will enjoy the change of pace that retirement and the resultant reduced schedule brings. But, he cautions, "I may slow down - but don't look for me rocking on the porch."

*"I remember Dr. Kent as a teacher with super-organized thoroughness in the classroom and incisive exegesis. I have greatly benefitted by watching the godliness of Dr. Kent and pray that I will be able to multiply in other young men's lives the investment that he has made in me."*

# The Board of Trustees



**EDITOR'S NOTE:** The following profiles comprise the first group in a series designed to introduce the members of the Board of Trustees for Grace College and Seminary.

It is the primary responsibility of the Board to establish the direction of the institution, determine the policies by which the college and seminary are to be governed, and choose the necessary officers to administer those policies. Trustees come from throughout the country to serve Grace College and Seminary in this crucial way.

Board members are elected on the basis of the following criteria: spiritual maturity, occupational diversity, executive experience, appreciation and understanding of higher education, availability and motivation, and financial support within individual means.

The Board voted recently to restrict membership to five consecutive elected terms, three years per term. Three men will conclude their terms of service and retire from their positions in 1991: Dr. Robert L. Boze, Mr. Richard Holmes, and Rev. Jerry S. Young.



## Dr. Robert L. Boze

Dr. Robert L. Boze, M.D., resides in Berne, Indiana, with his wife, Phoebe. He has practiced medicine there for 38 years. They had three sons: Jeffrey (B.A. Grace College '76), Michael (B.S. Grace College '78), and Timothy. Timothy, their youngest, died in an accident at age nine.

Shortly after trusting Christ as a boy of 12, Robert Boze began attending Bethel Brethren Church near Berne. He remembers hearing Dr. L.S. Bauman and Dr. Alva McClain speak there in the late '30s and early '40s. They were his first acquaintances with Grace Seminary, and they deeply impressed him with their Bible knowledge.

He also credits Rev. True Hunt, a Grace Seminary student who eventually became his brother-in-law, and Rev. William "Bill" Schaeffer with having great influence on his life as a Christian. "Their godly faithfulness was a real inspiration to me," he says.

Dr. Boze graduated with a Bachelor's degree from Indiana University in 1949, and an M.D. degree in 1952.

"My Christian faith has served as the rock to build my life on. God gave me a wonderful Christian wife, and all our sons accepted the Lord when they were young. We are thankful for their Christian homes and families."

Together with Phoebe, Dr. Boze has served in that same Brethren church for many years. He has been Vice Moderator, Chairman of the Building Committee, and continues to serve as a Deacon, Sunday School teacher, and worker with the junior church ministry.

Dr. Boze was first elected to the Board of Trustees of Grace College and Seminary in 1975. As a member of the Board he has worked on the Development Commission and the Student Affairs Commission. "I accepted appointment to the Board of Trustees because I hoped I could have a part in helping the school to grow and train more young men and women."

Dr. Boze will be concluding his term of service on the board in the fall of 1991.

"I believe strongly," he says, "in the ability of Grace College and Seminary to train men and women to put the Lord first in their lives and to serve Him in lay ministry or as pastors and missionaries full-time."

He adds that he prays that churches will continue to support Grace and send their children there for education so that more young people will be adequately prepared to work effectively for Christ.



### Ralph H. Grady

Ralph H. Grady and his wife, Anna Mae, make their home in Waterloo, Iowa. They are the parents of four children and have 13 grandchildren. Grady is a retired farmer who continues to serve in his local church.

"Grace Brethren relatives praying - that's what caused the changes in my life," Grady says. In his late teens and early 20s, as his Christian faith and maturity grew, Grady became a member of the Grace Brethren Church in Waterloo and started teaching there. During those years he also attended Waterloo Bible Institute.

"Several pastors - Dr. J.C. Beal, Arnold Kriegbaum, Richard DeArney, and John Aebly - were used mightily in my life. They helped train me in a ministry and encouraged me along the way."

Grady's earliest contact with Grace Seminary was when men such as Dr. Hoyt, Dr. McClain, and Dr. Bauman would speak at conferences in Waterloo. This sparked an interest in Grace which drew him to attend National Conference yearly. "I saw some great pastors come out of Grace Seminary - many of whom served in the Waterloo church. It was during the years of Dr. Hoyt's presidency that I was approached about serving on the Board of Trustees. I felt that if the Lord could use me as a successful businessman, there would be no better place to serve."

For 41 years Grady worked as a Sunday school teacher in the Waterloo Grace Brethren Church. Those years prepared him and his wife for the ministry God has given them in the past 10 years.

Each winter they spend four to five months at Indian Creek Park, Ft. Myers, Florida. They began a weekly Bible study there in 1977, and by 1980 it had grown into a church service in the park with an attendance averaging 175. Attendance has been as high as 495. Grady also is involved in the teaching ministries of the Waterloo church during the summer

months and serves on the Deacon Board there.

He joined the Grace Schools Board of Trustees in 1969 and has served two separate terms of office with a combined length of service of 17 years. As a member of the Board, he has worked on the Business Affairs Commission and the Trustee Commission.

"I believe God has a great future for Grace as we trust Him and stay sensitive to his leading. It is encouraging to see the campus improvements that continue to progress. We must pray and use wise discernment as we seek the students and financial support necessary to keep the schools strong."



### Richard Holmes

Richard Holmes and his wife, Pauline, live in Smithville, Ohio. Holmes is a retired school superintendent from the Ohio public school system and currently a coordinator for the North Central Accrediting Association, coordinator of a public pre-school, and Adjunct Professor of Education at Ashland University. He and Pauline have two children, Beth and Keith.

"I was raised in a Christian home where my parents taught me the Scriptures and set good examples of how to live as a Christian. I always went to Sunday school and had the privilege of sitting under some great teachers. We often had pastors and missionaries in our home, a fact which also influenced my decision for Christ at age 12," Holmes remembers. "Pastor Kenneth Ashman, who served our Wooster Grace Brethren Church for 36 years, was a real inspiration."

Holmes graduated from Ashland College with a B.S. degree and earned a masters degree in education from Kent State.

"Regardless of where God has placed us, it has always been our goal to serve Him and live a consistent testimony."

Holmes serves in the Wooster Grace Brethren Church as Moderator and teaches an adult Sunday school class. He is president of the Wooster Christian School Board and chairman of the Wayne County East Camp of Gideons.

Holmes began serving on the Board of Trustees for Grace College and Seminary in 1961. During his years of service, he has been on the Educational Affairs Commission and the College Academic Affairs Commission.

He will conclude his term in the fall of 1991.

Holmes expresses his vision for Grace College and Seminary in this way: "We need a college and seminary to train our leaders, but it is also important to have trained Christians in all fields of secular work, not only to be able to do the

highly technical work, but also to be a testimony. The achievements of both the college and seminary have been numerous, and many qualified graduates are serving God. Both schools have held to the faith, while at the same time being willing to change methods and approaches in putting forth the Gospel."

In addition, he says, "both schools urgently need students. We must pray for the proper number of students to continue this mission."

Kurtaneck*

Dr. Nickolas Kurtaneck, Professor of Bible and Theology at Biola University, and his wife, Micky, live in Buena Park, California. They are the parents of Timothy and Charise.

Dr. Kurtaneck was a member of the Greek Orthodox Church and his wife a member of the Anglican Church of England. They were married in England in 1944 during World War II. Together they accepted Jesus as Lord at the Church of the Open Door in Greensburg, Pennsylvania, in February 1950.

Three men – Dr. A. Banker, Dr. Eugene Williams, and Dr. Lawrence Lawlor – were used of the Lord to teach Dr. Kurtaneck the doctrines of the Christian faith by their instruction and lives. "They constantly encouraged me to continue my education, to learn as much as possible, and to go as far as possible," Dr. Kurtaneck recalls.

"With the exception of the three years I spent at the Greensburg Bible Institute and two years at Biola University, I received all the rest of my academic training at Grace College and Seminary. My interest and feelings for the schools are rooted in my training at Grace and in my years of association with the Grace Brethren Church of Norwalk, California.

While at Grace College and Seminary, Dr. Kurtaneck earned his bachelors degree from the college (1957) and three degrees from the seminary – bachelor of divinity (1957), master of theology (1958), and doctor of theology (1961).

For 17 years Dr. Kurtaneck has been a pastor-teacher in the Grace Brethren Church of Norwalk, California. He has 32 years of teaching experience and has served in 11 churches throughout those years. He also is involved with the Japanese Evangelistic Band Mission.

"Having the privilege of serving Jesus through teaching and preaching is a continuous source of satisfaction and joy," he says. These opportunities have equipped him to serve

Grace College and Seminary in an effective manner for the glory of God.

In 1987 Dr. Kurtaneck joined the Board of Trustees. In 1988 he began serving on the Student Affairs Commission. His present term of office is 1990-1993.

"In both the college and the seminary, we must not allow material and monetary needs to shift our dependence from God, who has promised to meet all of our needs. We must not depend upon worldly means in place of God's provision.

"It behooves all professors, administrators, and board members to articulate to the Grace family the need to walk in the Spirit and live by faith, so that men and women can continue to be trained and equipped academically and spiritually to serve the Lord in multiplied professions throughout the world."



*Rev. Jerry R. Young*

Rev. Jerry R. Young and his wife, Loreen, live in Lititz, Pennsylvania. Rev. Young is Senior Pastor of the Grace Brethren Church of Lititz. They have four children: Jared, Jason, Justin, and Janae.

"The Lord shook me awake during a difficult period of my life, when I was about 15 years old, and though I had grown up in a Christian home and made an early profession of faith, it was then that He saved me by His grace," Rev. Young remembers.

He attended Grace College, graduating with a B.A. degree in 1961, and Grace Seminary, where he earned a B.D. in 1964. As a Chaplain (Colonel) in the U.S. Army Reserve, he has also studied in Army schools, completing the Command and General Staff Course in 1985. Presently he is working on a D.Min. degree.

Loreen (Summers) Young, his wife, graduated from Grace College in 1962 with a B.A. degree.

"My educational experience at Grace was used by God to redirect my vocational objectives and awaken my Christian commitment. The impact of Grace Schools on my life is enormous," he says.

The church in Lititz where Rev. Young and his wife minister has 550 members. There is also a Christian school with 276 students connected with the church. He works with the staff pastors and numerous full- and part-time personnel, numbering about 50, in all facets of the church's ministry.

Rev. Young is presently the Moderator of the Fellowship of Grace Brethren Churches and Chairman of the Strategy Committee of the FGBC. He began serving on the Grace Schools Board of Trustees in 1973 and is presently its Chairman. His term of service will end in the fall of 1991.

"Grace College and Seminary need to continue offering a training product that meets the needs of men and women called and gifted by God to serve the church, to prepare them for ministry and service in the Church of Jesus Christ," he states.

director in France and as European Coordinator. In fact, it was while he was European Coordinator that UFM opened mission fields in Germany, Ireland, and Italy. At the same time, he served as an adjunct faculty member for Grace Seminary, teaching summers in the Graduate Program in Missions.

"Dr. Nesbitt knows what is going on in the world of missions," says Al Larson, current General Director of UFM International. "He has a solid reputation in academics and strong Bible training. His excellent communication skills and outgoing personality attract people to him."

Dr. Nesbitt has no illusions about his new position. "I know there are difficult problems ahead related to political and historical issues, but I also know that the next 10 years can be very fruitful for missions."

Right now, it is the amazing opening up of the "last frontier" that excites him. "Eastern Europe and the Soviet Union are wide open," he says, "and I think we can contribute to this work in a mighty way before the Lord comes. That's why it is so thrilling."

Dr. Nesbitt's wife, Nancy, who worked as a part-time nurse at the Grace Student Health Center, says they have had missions on their hearts all along. "We are excited about getting back into missions," she says. "This move will open us to a bigger world."

Dr. Nesbitt feels good about the organization too. Based in Philadelphia, Pennsylvania, UFM has over 500 members, serving in 17 countries. He says, "UFM is an efficiently run mission and its personality is similar to that of Grace. Over 40 UFM members once studied at Grace. Theologically, it is conservative, and yet it is willing to improvise in doing new things."

Looking ahead, Dr. Nesbitt adds, "There are things facing missions in the nineties that need to be addressed." According to him, young people are the answer. Missions need to tie in with university and college students and with overseas study programs. "Once students have been overseas, their illusions are blasted, but they see the needs and they see where they can fit in. That's an area missions really have not touched."

And yet that is where Dr. Nesbitt is uniquely prepared to help, since he has been involved in overseas studies most of his life.

Dr. Nesbitt remembers his own years as a student in France, first as a high school freshman while his father directed the Sweet Briar Junior Year Abroad program, then as a Princeton undergraduate for his own Junior Year Abroad, and finally as a graduate student at Middlebury studying on a Fulbright and French government scholarship.

When he came to Grace in 1981 after his 17 years on the mission field in Europe, he says he inherited what most other schools try to do. "We were trying to teach the languages at all different levels, along with the literature. Now we just teach the language for the first two years, using native speakers. All the upper classwork is done in the country of the language. It spares us complications with curriculum and scheduling. But the students can go and get the very best in world in their particular areas, studying at the Sorbonne in Paris, in Tuebingen, Germany, or at the University of Madrid."

Because Grace students have to "tough it out" rather than having a paid staff member go with them, they save thousands of dollars. Dr. Nesbitt claims, "In many ways we have worked out a deal that is superior to any college in Indiana." The reason it works is because Grace language students can tie in with Grace alumni or other missionaries who are overseas. "It's really incredible that no one else has thought of doing it," says Dr. Nesbitt. "That's where even the big schools or Ivy League schools can't possibly compete with us, because they are not involved with missions and church planting."

When Dr. Nesbitt and his family move to Philadelphia this summer, no full-time professor will replace him. He feels good about leaving the program in the hands of the part-time instructors who currently teach Russian, Spanish, German and French. He smiles, "It's a little like the Boy Scouts. They are told to leave the campsite better than how they found it. I guess that is where I find real satisfaction working here at Grace. I see something that was good, and now we can leave it better than it was."

Something that Dr. Nesbitt says is "hard to leave" is the "Chouette (pronounced shwet) Children's Language" program, which he started in 1981 at Grace. Designed for pre-school through eighth grade students, the program helps children learn German and French—and have fun. In fact, Dr. Nesbitt tells the students, "If you're not having fun, then don't come to class anymore." They learn too. This year his Chouette students won top awards in the National French Contest, competing with over 80,000 other students.

Nancy adds, "It pulls to leave Grace. It's hard to imagine not being so closely connected to Grace. We'll miss friends; we'll miss the church."

However, continuing a pattern Dr. Nesbitt started the first time he and his family served under UFM, the break with Grace will not be complete. He plans to continue teaching in the Graduate Program of Missions at Grace Seminary each summer.
