# Now for the really good news

Reading newspapers these days can be very risky.

Many finish their daily edition with a sense of depression and despair as their world unravels before them. What is worse, higher education—the hope of many—is coming apart at its moral seams.

Campuses that were once noted for their spiritual atmospheres and biblical stands find their intellectual landscapes polluted with morally toxic debris. In fact, some university-sponsored or permitted activities are beginning to make Sodom and Gomorrah look like hotbeds of moral restraint.

The collapse of genuinely spiritual values in higher education could not have come at a worse time. The world in the past two decades has mounted a frontal assault on all that is moral, gentle, and of good taste, and has done so with disturbing success. Civilized values and human dignity have been trampled under the feet of the “Let it all hang out” gang.

The world of visual and musical entertainment now openly promotes the grotesque, morbid, shocking, and the sexually degrading. Teenage spiritual sensitivities have been shattered under the thin guise of the “Tell it like it is” philosophy on the part of those whose goal it is to crush all fundamental standards of moral behavior.

Now for the really good news.

Moral and spiritual values at Grace College are regarded by students and faculty alike as things to be protected and propagated, not discarded.

At Grace, the eternal Word of God is not just a dusty document residing in a museum case as a relic of the school’s past allegiance as it is in some institutions. It is the basis of the values taught, and the behavior patterns required, in the everyday experience of the student.

Our faculty promotes an academic environment where things lofty, pure, and beautiful are praised rather than crushed under the heel of contemporary cynicism.

The Lord Jesus cut right to the heart of the matter when He was confronted by the crafty Sadducees who wanted to destroy the doctrine of the resurrection and embarrass the Savior: “You are in error,” He announced, “because you do not know the Scriptures or the power of God” (Matt. 22:29).

One of our top priorities for at Grace College and Theological Seminary is to know the Scriptures and the power of God more deeply. The Sadducees certainly knew the Torah as a matter of literary analysis, but they had become manipulators of the text rather than its servants. Therefore, not really knowing the Word of God, they were incapable of being humbled by it.

The human wreckage and collapsed ministries on the landscape of the Christian church are more than adequate evidence that knowing the facts of Scripture is not enough.

The key to victorious Christian living and ministry is properly knowing the Scriptures and the power of God. We need His power for personal witness and personal purity.

If these are values you share with us, would you encourage a prospective student to consider Grace College or Seminary for their educational experience?

Just as this issue was going to press, we received a report that Grace College and Grace Theological Seminary will be receiving a bequest of \$375,000. This bequest is designated for a scholarship endowment fund, to be used for college and seminary students preparing for Christian ministry. ## Remodeling projects

Two of the latest remodeling projects on campus are the Little Theatre (above) in Philathea Hall and Morgan Library (right). The Little Theatre received not only a complete facelift, with new seating and the addition of carpeting, but also new state-of-the-art interactive audio and video systems. The Little Theatre is used for classes and for special events such as lectures and drama productions. The remodeling of the interior of Morgan Library consumed several months and required the moving of every bookshelf for replacement of carpeting. More than 3,000 square yards of new carpet was laid. Future renovation projects at Grace include classrooms in McClain Hall with interactive audiovisual facilities.



## New book honors

### Dr. Homer Kent

## Phone-a-thon raises \$46,000

Grace Phone-A-Thons are a semi-annual effort by the college and seminary to keep in touch with many of its alumni and friends.

The Fall Phone-A-thon this year occurred from September 30 through October 10, with approximately 30 Grace College students placing calls and asking for support for the 1991-1992 annual fund.

The response was overwhelming, according to Chris Becker, Director of Development. "With an ambitious goal of \$45,000," Becker said, "the final total pledged is \$46,000. We are extremely grateful to the hundreds of supporters who have responded to the Phone-A-thon."

Most of the funds raised will be used for scholarships and financial aid.



## Awarded Bronze Star

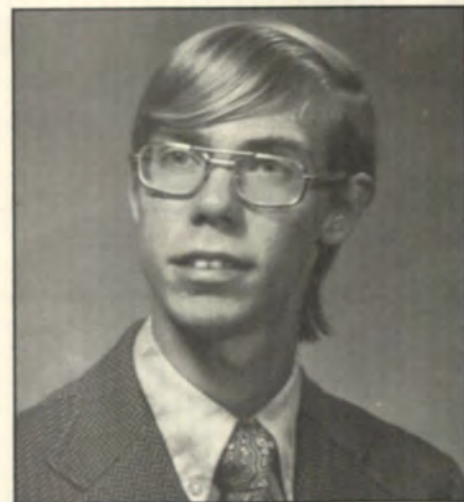

## Dan Devries shares faith in health facility

On April 5, 1978 the headline of the Warsaw, Indiana, *Times Union* read "Train Slams Into Car." The driver, a young man of 20 was transported to a Ft. Wayne hospital—his condition critical.

Dan Devries, at the time a student at Grace College, was not very far from his parents' Winona Lake home or from the Grace College campus that day when the car he drove crossed the path of that westbound train. Dan suffered massive injuries, multiple fractures, and was comatose.

The coma lasted four months—the hospitalization stretched long past that.

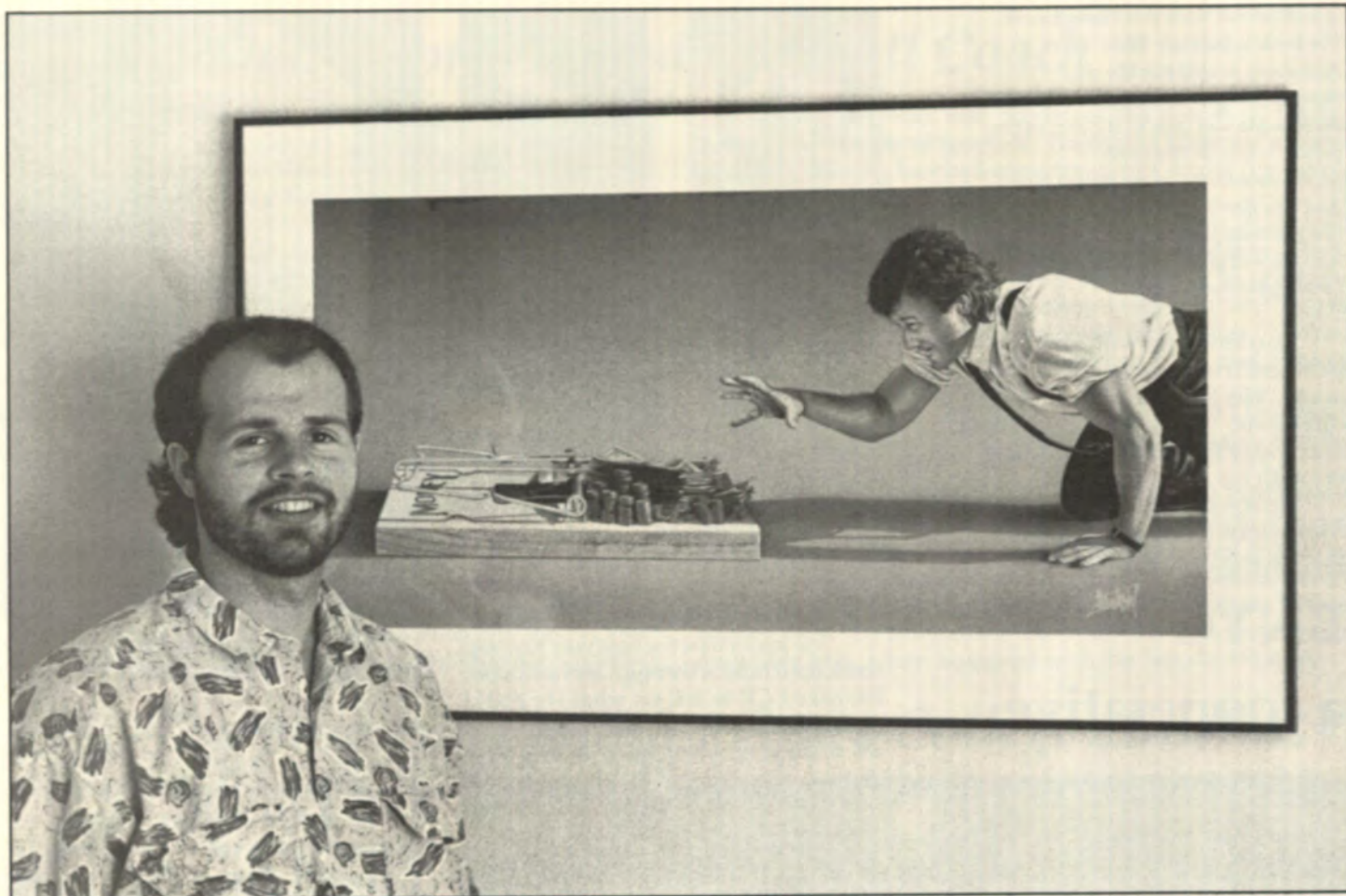

Then came the years of repeated surgical procedures, and the grueling work of rehabilitation and therapy.

Over these past 13 years Dan has had to learn to walk again, to care for himself, to do all the little jobs that once

came so easily. His ability to speak was so altered that it was necessary for him to learn sign language to communicate.

In April 1988 Dan moved into St. Vincent New Hope, a residential facility located in Indianapolis where he is currently living. There he receives assistance in dealing with the traumatic brain injuries he sustained in the accident and his resulting disabilities.

It is there that he also gives back as much as he can of himself and his faith.

"Dan is happy to help around here in any way he can," says Karen LaBrash, a therapist who assists Dan. "He is quick to volunteer and will make a point of asking if there's anything he can do."

But, the most powerful way in which he reaches out is through his writ-

ing.

"Dan does quite a bit of writing. Since he is unable to get his thoughts across quickly—especially if the listener doesn't know sign language—he often relies on the written word," LaBrash adds "and it isn't an easy process."

Dan's writings are sometimes humorous, often peppered with his dry wit. He even wrote the words that were chosen to be the St. Vincent New Hope cheer.

"It's a labor of love for Dan to sit and work through a writing project," explains Jean Devries, Dan's mom. "But he keeps at it because it is a way he can once again be heard."

Certainly Dan speaks most powerfully when he opens his heart on seri-

ous topics. He recently wrote the text for "A Morning Inspiration" the daily devotional broadcast throughout St. Vincent New Hope.

He also wrote the following poem which was included in a collection of works printed by the St. Vincent New Hope facility.

Remember, when you are feeling blue  
And your life feels like it is in a stew,  
Remember there was someone just like you,  
Who knows just what you are going through.  
Jesus Christ is his name.  
Saving lives is his game.  
He even cured the lame.  
He can solve all the world's woes,  
And can bring people up from their lows.  
All His accomplishments can be found in

a well known book that I have found.  
The book is the Holy Bible.  
And many people just like me,  
Strive to live just like Him,  
Because He was (and is) the only perfect  
person to live on this earth.  
So, the next time you are feeling blue,  
And you don't know what to do,  
Just ask Jesus what to do.  
And He will give you an answer.  
I will guarantee you.

Dan struggles with limitations and pain and frustrations that few will ever know. His life didn't take the expected directions. But he has determined to find a way to speak and encourage others with his faith.

He is succeeding because his words come from a depth of experience and reach the hearts of his readers.

## BNYC a cooperative effort

"We're here to serve. How can we help?"

That was the question asked over and over as Grace College staff members worked beside CE National in August to make Brethren National Youth Conference '91 a big success.

CE National annually takes on the challenge of orchestrating the youth portion of national conference for the Fellowship of Grace Brethren Churches (FGBC). The job is huge and growing—1,792 young people attended this summer at Flagstaff, Arizona.

"It was so exciting to see Grace College people taking an active, serving attitude," says E.J. Underwood, Chief Financial Officer for CE National and Associate Director of BNYC. "They made a special point of getting to know the young people by living in the dorms with them, working at the registration tables, driving shuttle vans across campus, or handing them a cold soft drink when they arrived hot and tired.

"Grace provided music and skits and whatever help we needed. They worked with us, serving wherever the need arose," Underwood adds.

And the administration and staff of Grace Schools were anxious to do just

that—serve wherever they were needed.

"We looked at the opportunities that were there—the chance that we had missed in the past—to meet young people from the Fellowship and get to know them; to show them what we at Grace are like and show them the best that Grace has to offer. We say clearly that it was time to grasp those opportunities," says Carl Beridon, Dean of Enrollment for the college.

"We know that the best way to grasp work for Christ is through servanthood. We asked CE to tell us what we could do to help. BNYC is their project, and we wanted to participate in any way that would help reach the young people and make the week go smoothly," Beridon explains.

Grace College offers great things for young people—a quality education founded on biblical principles with the purpose of training for service as the framework. But Grace exists only for and with the students' participation.

CE National has its finger on the pulse of all the students in the Fellowship of Grace Brethren Churches, according to Beridon, and those students are bright, talented, and committed to Christ. Underwood adds that tradition alone is not enough to hold young adults in the Fellowship. Grace College is a major link in demonstrating to Brethren young people the importance and advantages of remaining in the FGBC and in preparing them for Christian service as adults.

"We appreciate the support that we have received in the past from CE and the churches. We want to do whatever it takes to keep that relationship strong," says Beridon.

"I agree," adds Underwood, "CE and Grace are separate institutions that are striving to serve Christ together. BNYC is a good place to lock hands and watch what God will do as we willingly serve together."

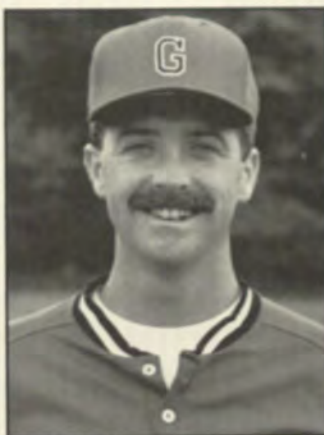

## Don Gordon becomes Head Baseball Coach

Former Toronto Blue Jay and Cleveland Indian pitcher Don Gordon is the new Head Baseball Coach at Grace College.

The 32 year-old Gordon comes to Grace after spending the past nine seasons playing professional baseball. After putting up career best stats (1.69 ERA in 1991) with the Syracuse Chiefs, Triple-A affiliate of the Toronto Blue Jays, Gordon made a decision based on his personal faith to retire from professional baseball and pursue a career in the ministry through coaching and speaking.

He will serve as the Head Baseball Coach at Grace while also serving on the staff of Unlimited Potential, Inc., in Warsaw, Indiana. Unlimited Potential is a worldwide Christian

outreach organization that proclaims the gospel of Christ through the vehicle of baseball. Unlimited Potential's main focus is in offering baseball-ministry camps across the country and around the world.

Unlimited Potential Executive Director Tom Roy met Gordon while Gordon was with the Cleveland Indians. "Tom and I thought it would be a great opportunity to combine Unlimited Potential and Grace College in my ministry. This is a chance of a lifetime for my family and me," states Gordon, who has received calls from the Chicago Cubs and Boston Red Sox after deciding to coach at Grace.

"To be able to minister through the sport that I love, and to work at a Christian college with quality kids—this is truly a great time in my life."

Gordon signed with the Detroit Tigers in June 1982 before going to the Toronto Blue Jays in 1984. He saw his first major league action in 1986 with Toronto and was traded to Cleveland in 1987 for future Hall-of-Famer Phil Niekro. Don remained with the Indians through the 1989 season before signing with the Milwaukee Brewers. He remained there until May 1991, when he signed with the Toronto Blue Jays.

## 1991-92 a promising year for Grace College athletics

Fall sports came alive at Grace as the students made their way back to Winona Lake for the start of another year.

Expectations were set high at the beginning of the year for all of the athletic teams, and if other Grace teams follow the example of the Lancer tennis, volleyball and soccer programs, 1991-92 will be one of the most successful years in Grace College athletic history.

The age and experience of the **Grace volleyball team**, along with the fact that this is Coach Steve Fleagle's first season at the helm, indicate that this will be a rebuilding year for the team.

"Half of the girls are in their first year of college volleyball, so this year they're also getting acclimated with college (life) as well as college volleyball," says Fleagle of his young team.

Leading the Lady Lancer attack this season is 1990 MVP Shannon McGarvey, a junior from New Paris, Indiana, and Virginia Larson, a junior from Princeton, Illinois. McGarvey led Grace in kills again this season, and Larson, recovering from a fractured wrist most of the year, was one of the keys to success as she healed.

Freshmen Marci Norris, a native of Kokomo, Indiana, and Allison Chrismer,

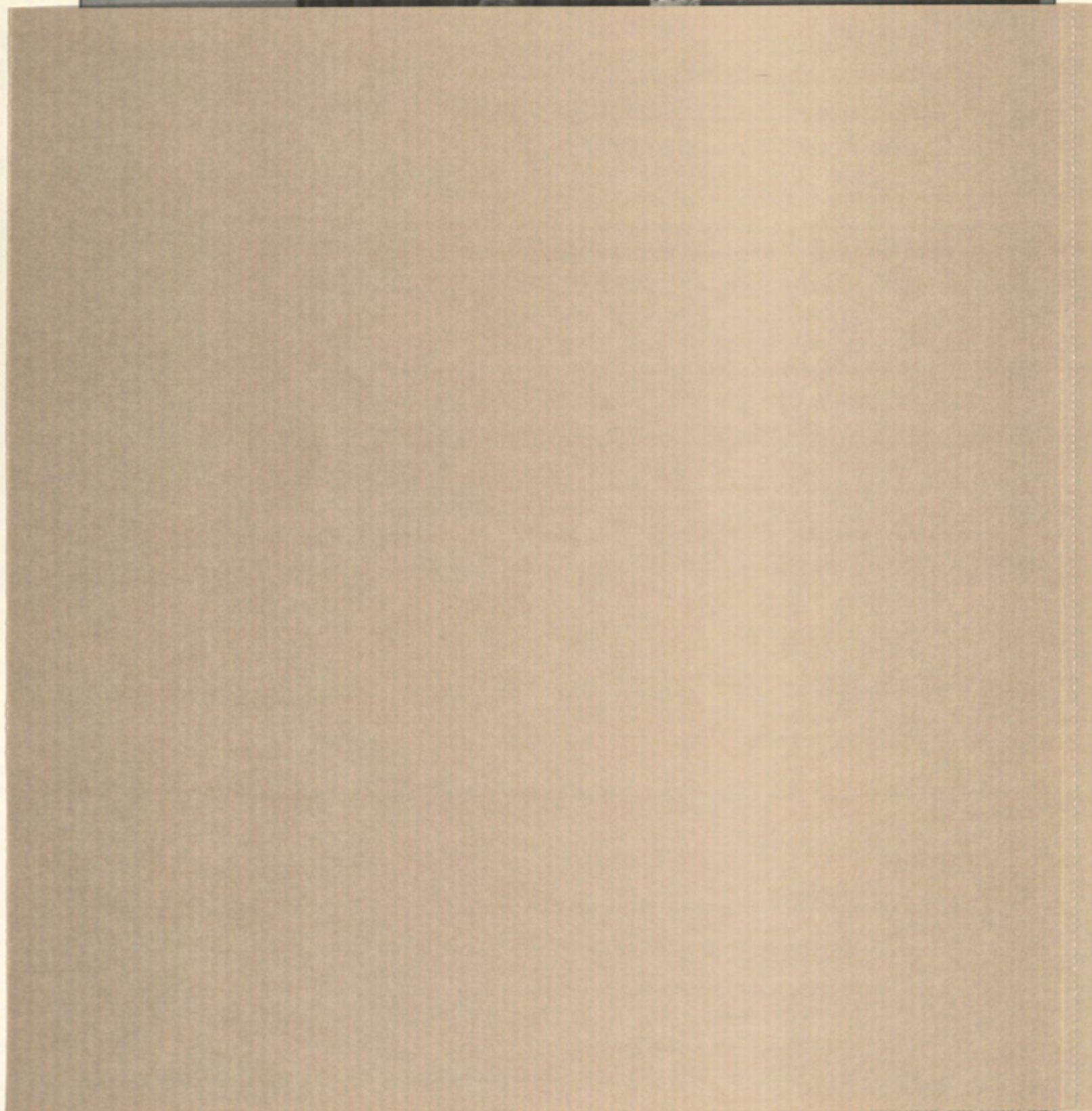

undefeated record as they approached the halfway point of the season, the Lancers finished the year with a record of 10 wins, against only two defeats.

Nathan Weirich, a freshman from Hagerstown, Maryland, led the Lancers for the season at the No. 1 singles position. Weirich's doubles partner, and No. 2 singles player, Josh Grill, a junior out of Winona Lake, Indiana, also turned in a spectacular season. Grill and Weirich each received post season honors as they were named to the all-MCC and all-NAIA District 21 squads.

Also turning in a good season for the Lancers was Chris Benyousky, a sophomore from Warsaw, Indiana, who won the district championship at the No. 5 singles position. Benyousky then teamed up with Tim Fisher, a senior from Toledo, Ohio, to claim the district championship at the No. 2 doubles spot.

Also contributing heavily to the success of the 1991 tennis team was sophomore Bill Zoeller, from Rochester, N.Y.;

seniors Deron Datzman, Lafayette, Indiana, Greg Huffman, Warren, Ohio, and Randy Campbell, Romeo, Michigan; and freshman Jeff Blackburn, Westerville, Ohio.

Rounding out the success of the fall athletic program at Grace is the **1991 soccer team.**

Led by Coach Ray Kordus, who is completing his sixth year at Grace College, the Lancers were in a storybook season of their own as they went undefeated through their first nine contests.

Rougher times were ahead, though, as the Lancers then dropped four of the remaining eight games to finish the regular season with a very respectable 12-4-1 record. The Lancers then went on to NAIA tournament play, where they defeated Indiana Wesleyan, 1-0, in the first round, before falling to host Taylor, 1-0, in a double overtime shootout.

The team currently holds down a 13-5-1 record as it awaits word on whom

it will be playing in the first round of the NCCAA Tourney.

Grace was led again this year by 1990 NCCAA all-American Corey Rose. The junior from Warsaw, Indiana, has a team-leading 17 goals and looks to lead the Lancers to a championship in the NCCAA.

Other Lancers that contributed greatly to a successful season include junior goalie Jeff Trimble, out of Dayton, Ohio. Trimble recorded nine shut-outs this year, enjoying his finest collegiate season. Sophomores are the core of the team as Alwin Arendse and Brent Annis, both from Columbus, Ohio; Steve Thomas, out of Dayton, Ohio; and Brett Schuster, from Laverne, California, have provided Grace fans with a glimpse of the future in leading the Lancers throughout the season.

Co-Captains, and 1990 academic All-Americans, were seniors Tim Mathisen, from Warsaw, Indiana, and Tim Custer, from Columbus, Ohio.

While a number of evangelical seminaries offer Doctor of Ministry degrees, the program at Grace Seminary provides a number of innovations. One unique characteristic is Grace's focus on personal assessment, in which participants receive help in assessing their personal strengths and weaknesses and in developing strategies to enhance the relational areas of their lives—including family, church family, and their personal walk with God.

D.Min. students complete eight five-day seminars and associated out-of-class assignments in order to qualify for the degree. In addition, Grace offers two other options under its D.Min. "umbrella": (1) non-degree students may participate in the five-day seminars as a means of continuing education at a reduced tuition rate, and (2) pastors and other Christian leaders may attend one-day Christian Leadership Seminars offered by well-known D.Min. faculty.

# McClain Heritage Society established

Planned Giving Officer Dr. William Male has announced the establishment of the McClain Heritage Society for donors who are involved in "planned giving" to Grace College and Grace Theological Seminary.

According to Dr. Male, the new society was established in honor of Dr. Alva J. McClain and his wife, Josephine McClain. Dr. McClain was founding President of Grace Theological Seminary in 1937 and Grace College in 1948.

"Dr. and Mrs. McClain worked tirelessly and sacrificially to lead in the establishment and growth of both schools," Dr. Male said. "Their work extended over three decades. In addition, for more than 22 years after Dr. McClain died in 1968, Mrs. McClain continued to support Grace with regular gifts and investments in annuities. Her final act of generosity was making Grace the primary beneficiary in her will." She died in 1990.

Dr. Male explained that the new society has a two-fold purpose.

"First of all, we want to provide a means of recognizing those donors who have already made gifts to Grace College and Seminary through gift annuities, charitable remainder trusts, life insurance policies, and/or have included Grace College and Seminary in their wills or revocable living trusts. Second,

we hope the existence of the McClain Heritage Society will stimulate interest among others to consider the benefits of planned giving to this ministry."

Members of the McClain Heritage Society receive the quarterly President's Associates Newsletter from Dr. John Davis, President of Grace College and Seminary. In addition, members will be sent a certificate of membership and a copy of *A Saint in Glory Stands*, the biog-

raphy of Dr. McClain written by Norm Rohrer, as long as the current supply lasts. All the copies contain a signature page signed by Mrs. McClain, as well as the three presidents who followed Dr. McClain at Grace—Dr. Herman Hoyt, Dr. Homer Kent, and Dr. Davis.

In addition, there will be other special communications from time to time, as well as invitations to selected special events.

"In any case," he added, "people considering these financial steps should feel free to review the options they are considering with an attorney or tax consultant."



# Old friends remember the McClains and their dedication to Grace

Dr. Homer Kent, Professor Emeritus at Grace Theological Seminary, and Dr. William Male, Planned Giving Officer for Grace College and Seminary, are two of a number of people around the Grace campus today who have vivid memories of Alva and Josephine McClain.

"Dr. McClain was a great teacher,"

Dr. Male said in a recent conversation with Dr. Kent. "He had a great ability to communicate. He could take complex ideas and make them very simple for the student. In addition, he was a great one for using illustrations in his lectures. I've quoted him many times in my own teaching and preaching."

Dr. Kent agreed. "Dr. McClain was very, very effective in the classroom, and both he and Mrs. McClain were very dedicated people—dedicated to the Lord and dedicated to the ministries of Grace College and Grace Theological Seminary. They were very precise people, very particular. For example, when they built their home, Dr. Mc-

Clain designed it himself, with great attention to detail. And he designed McClain Hall, too. He did a drawing of the building and the floor plan and gave it to the architect, who took it from there. He even made a model of the building before it was actually constructed.

"Mrs. McClain was meticulous, too."

For many years, she worked by Dr. McClain's side in the Grace ministry. She had bookkeeping and secretarial skills and kept the financial records for the school. She was the one who wrote out the paychecks back when I first began teaching here. She did that job for a long time, and for all those years, she did it without taking any salary."

Focusing on the newly formed McClain Heritage Society, Dr. Male added, "I think it's appropriate to name this recognition society after the McClains, in light of all they have meant in the development of this ministry. In view of Dr. McClain's reputation as a theologian and teacher, and the role he played

as the founder and first president of Grace College and Grace Theological Seminary, he certainly deserves whatever honor we can give him."

Dr. Male added that the name of the new organization for planned givers includes the concept of "heritage" for a good reason. "We want to clearly communicate the continuing commitment of Grace College and Seminary to those theological truths and spiritual values that meant so much to the McClains and the many other people who helped establish this ministry and who have supported it so consistently over the years."

Board members are elected on the basis of the following criteria: spiritual maturity, occupational diversity, executive experience, appreciation and understanding of higher education, availability and motivation, and financial support within individual means.



## John Armstrong

John Armstrong resides in Wooster, Ohio, with his wife Gloria. He owns a meat and poultry distributing company. The Armstrongs are the parents of two sons: Dan and Dave.

"I came to know the Lord in my late teens through the ministry of Pastor Ken Ashman and the people of the Wooster Grace Brethren Church, who showed such an interest in me," Armstrong relates. "And through the years the Lord has confronted and challenged me by significant events which have changed my life.

"My faith in the Lord Jesus has helped to guide our family and business, giving us stability in both high and low times. I thank the Lord for my godly wife, the prayers of my

are the parents of two daughters, Teresa and Vanessa.

"I was just a toddler when Dad entered Grace Seminary in 1943. Three years later he became a Brethren pastor and 'Grace' became a household word for our family. All six of us, my brothers and sisters, grew up planning to attend Grace. Except for our younger brother, who went to be with the Lord when he was a high school senior, we all did," says Horney.

Through his father's ministry, Horney was led to accept Christ as personal Savior. "I learned from Dad that I had to put God first, and from there my priorities would fall in place," he adds.

In 1963 Horney earned a B.S. degree at Grace College in elementary education. He holds a masters degree in education from Mt. St. Joseph College and has done graduate work at Ashland University and Kent State University as well.

Charlotte (Henning) Horney, his wife, also graduated from Grace College with a B.S. degree in education.

Since that time he has attempted to focus his life on knowing God and obeying Him. "My wife and I try to always see God's will as the bottom line for decisions, both personal and those related to our ministry."

Rev. Nutter graduated from West Virginia University and then earned a M. Div. degree from Grace Theological Seminary in 1974.



# *“Why not you?”*

---

“During the last decade, Indiana’s prison population has more than tripled. The demands on an already overcrowded system, both financially and in human resources, have been overwhelming. Our correction system has been scrambling just to provide enough beds to house people, with virtually no time left for meaningful rehabilitation.

“Into this dismal state of affairs, Ken Taylor and his colleagues brought a fresh vision of ways in which Indiana could respond to crime by responding to the people it affects—the victim, families, correctional employees, and the offender. The notions of individual accountability and personal attention which are the hallmarks of their approach, have resulted in a major restructuring of our correction system, with an increasing emphasis on community-based alternatives, and incentives for people to bring themselves out of a cycle of crime and dehumanization.”

*It was one of those early spring snows. It came unwanted and unexpected—clogging the roads, closing businesses and schools. The State Highway Patrol monitored the worsening conditions and started shutting roads, urging people to stay home and stay safe.*

*But Ken Taylor had an important reason for being on the road. He drove cautiously. Leaning forward, he strained to see the road. Indianapolis 30 miles . . . the sign was barely legible through the blurred white.*

*A friend of Ken’s was going before a judge that day. At Marion Supreme Court, Indianapolis, Indiana, Norm, an inmate at Indiana State Prison, waited for his friend and brother Ken.*

*They took their places in the room, and along with the others present, heard the decision. The presiding judge granted Norm’s sentence modification for one reason: Norm was radically changed by Prison Fellowship and the impact of the men from Grace College.*

---

It was in 1976 when Ken Taylor was given a copy of Chuck Colson’s book, *Born Again*. His life has never been the same.

“I read it quickly,” he remembers, “and I was struck with one hard fact. It was time for me to link all my studying and knowledge about sociology and criminology with my faith.

It was time to do more than just read and lecture on the topic. It was time to get involved."

By 1980 Ken was active with Prison Fellowship (PF), an organization founded by Chuck Colson for the purpose of discipling inmates in prisons across the country. Through PF, Ken taught Bible studies, led seminars, and instructed some non-credit classes.

He met men who also served as leaders . . . men like Al Evans, owner of an advertising and marketing firm in Merrillville, Indiana. "Ken gave of himself in such an incredible way," Evans says. "He travelled to many different areas to teach and always developed genuinely close relationships with the men."

Ken also met men in those classes who were hungry for more.

"In 1985 several of us began asking the inmates at Indiana State Prison (ISP), a maximum security facility in northern Indiana, how PF could better meet their needs," Ken explains.

Boldly they said: We need college classes here at the prison.

Then they turned to Ken, a Professor of Sociology at Grace College, and asked: "Why not you? Why not Grace?"

The questions etched deeply into Ken's mind and heart during the next few days. He took that plea, combined it with his personal dream to reach inmates effectively, and went to work.

During the next several months Ken secured the necessary permission from the Indiana Department of Corrections and an agreement to participate from the administration of Grace College. He worked through the Office of Financial Aid at Grace to obtain Pell Grants for the men and then began the task of raising the rest of the necessary funds through donations and gifts.

Within the walls of the prison a room was located which, with some work, would serve well as a classroom. The inmates cleaned and painted the room. They arranged desks and made space for books.

Then in the fall semester, 1986, the first class of Grace College at ISP met in that room. The men began work toward their associate degree in Biblical Studies.

"We started small," Ken remembers, "because many of



the men had to be re-introduced to the disciplines of reading and studying, and strengthened in their abilities of critical thinking, analysis, and application. I also wanted the instructors to be able to really get to know the men."

Dr. Ted Hildebrandt, Professor of Biblical Studies at Grace, was one of the first instructors.

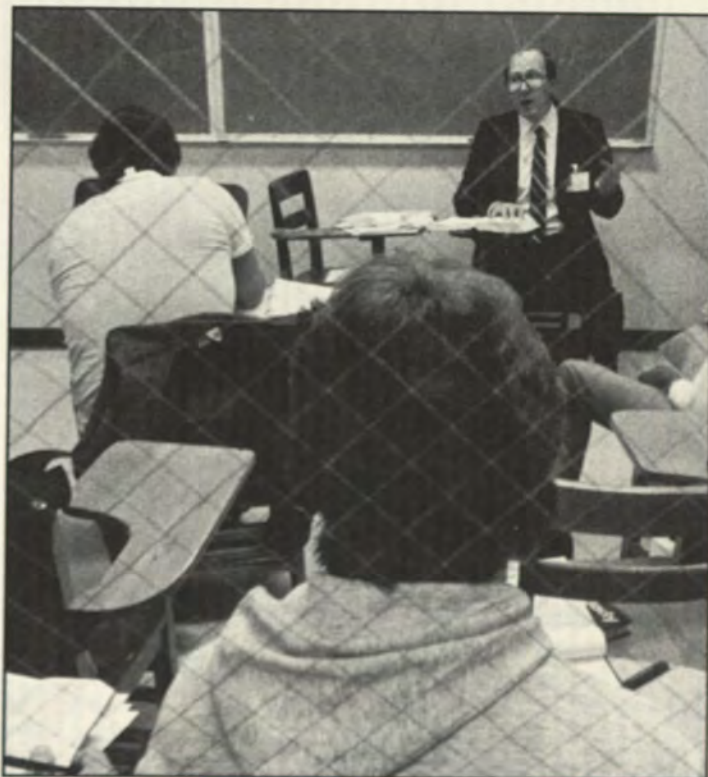
"I'll never forget the sensation of the first time as I walked to the classroom and kept hearing doors slammed shut and locked behind me. We went through seven sets of barred gates before we finally arrived. It was a frightening, claustrophobic feeling. Then, one of the guys said to me: 'This is the happiest day of my life, sitting here being taught Bible on a college level in a place like this.'

"I may teach them the Bible, but they teach me God," Ted says. "Those men have had everything stripped away. All they have is God, and they are among some of the most godly men I've ever met.

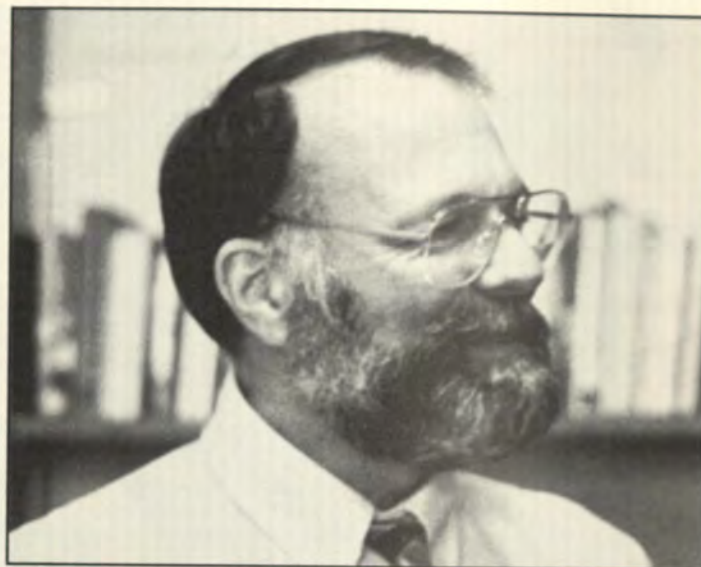
"I go to the prison one day a week, and it's the most refreshing thing that I do. I feel alive in God, renewed in my sense of calling. And they are not afraid to disagree with me or push me to better explain something. They really want to know who God is and what it means to live for Him. Knowing them has given me a vigor to wrestle with problems and a clearer focus on why I teach the Bible. I remember that this is what Jesus would be doing, teaching the ones whom the world had given up on."

Along with Ken and Ted, other instructors at ISP have been Dr. W. Merwin Forbes, Prof. Frank Benyousky, Dr. Don DeYoung, Dr. Bob Mathisen, Dr. Ed Glascock, and Prof. Sam Wolfe.

"I just started teaching at ISP in 1989," says Prof. Frank Benyousky, Assistant Professor of Communications. "When I arrive they always shake hands and many will hug me. I

went there thinking I would be giving something to them—and I guess I have in some way—but more to the point is all that I receive from them.

"They have welcomed me and cared about me. We have grown together and struggled together. It is exciting to study literature with them and hear them apply it, make it come alive. We raise serious life issues in our discussions and they have a realism that's refreshing.

"These are men who have been shaken to the core. Some of them show attitudes that I wish I could manifest. Meeting them and working with them is an energizing experience both personally and academically."

Ken explains the long-term educational goals of the college's program at ISP:

"We are really focusing on teaching the men to take responsibility for each other. ISP is filled with long-timers, and they operate under the code, 'Do your time by yourself.' That attitude is counter-productive to future life in a society where one is expected to live respecting the rights of others. Instead of this we are trying to develop a sense of community."

Ken recently combined two ISP classes (the men who started out in the original group and a newer class) into one. He wants the newer group to see and reach toward a higher level of working and thinking and participating as demonstrated by the first group. Conversely, the "veterans" must realize that it is their responsibility to bring the newer ones along and facilitate their growth and success.

"Our ultimate goal for each man is that he learn to think well and make good decisions. If he will get out, we want him to be faithful to his Christian walk and make a positive contribution to society; to live a principled life in service to others.

"If he will not get out, we want him to see his significance as a Christian man and teach him to live a consistent Christian life in prison."

Chuck Adkins, Assistant Superintendent in charge of programs at ISP, says the Grace College program has had a significant impact on the lives of the men. "Most all of the

# Bird-watching in Tanzania part of life for Grace College biology graduate

When David Moyer commutes to work, it's 200 miles through the southern highlands of Tanzania, East Africa, to the Uzungwa Mountains. Many of those miles have actual roads, but some would be better described as frequently traveled tracks through the bush. The last few miles must be travelled on foot.

David is a 1986 graduate of Grace College. Now, as a graduate student in zoology at Louisiana State University, he is conducting field research about the birds that live in the mountain forests of Tanzania.

Tanzania? That seems to be stretching the definition of "field" research to the limits. But to David, it's just bird-watching in his back yard.

In 1950, Rev. Otto Deming founded Livingston Memorial Mission and built the first station at Tatanda in Tanzania. His daughter Joanne grew up on the mission field in Zaire and Tanzania. During studies at the Summer Institute of Linguistics in Oklahoma she met Carl Moyer. Carl was single and had just returned from a term of service in Zaire (then the Belgian Congo). They married and returned to serve at Tatanda. David, their oldest son, grew up at the mission station there.

In 1982 Joyce Mason graduated from Grace College with a degree in nursing and went to Tanzania as a summer medical volunteer. She worked in the health center at Tatanda mission where she met David.

Joyce was no stranger to missions. The daughter of Dr. and Mrs. Harold Mason, she was born in the Central African Republic and had lived there for eight years.

After her summer in Tanzania, Joyce returned to Indiana and enrolled in a nursing program at Ball State University. David came to Grace College in 1982 to study biology.

Growing up on a mission station in a family with such a heritage of mission service, David felt pressured to be a "traditional" missionary. "But it was not my desire or calling—it was exter-

nal. While I was at Grace College I decided that working in natural science and conservation biology was what I was called to do," David remembers.

While a student at Grace, David excelled in his major classes. As an upper-classman he assisted Dr. Richard Jeffreys in the laboratory.

"He always did a super job," Dr. Jeffreys relates, "but when the birds were migrating I would have to go outside and get him and bring him back into the lab."

David completed his degree and graduated in May 1986. He and Joyce returned to Tanzania in June that year and were married at Tatanda mission. After that, they spent 10 months of volunteer service at Tatanda then returned to the U.S., where he and Joyce lived and worked in the Winona Lake area for a year. During this time their first child, Shera, was born.

In 1988 David was accepted into

the graduate program in tropical bird ecology at Louisiana State University. "The first year was really hectic," he recalls, "carrying a full load of classes, a teaching assistantship, writing grant proposals, and trying to spend time with my family."

By early summer of 1989 one of David's research proposals was funded by Wildlife Conservation International (the conservation wing of the New York Zoological Society). The whole family set out for Tanzania again, to begin field work.

"As a graduate student, David has received more money in grants than any other student in his department," says Dr. Jeffreys. "He is committed to working long-term in conservation biology in Tanzania, and the funding organizations recognize that."

Looking back on that first trip David remembers, "Due to logistical and bu-



reaucratic delays, it ended up being more of a fact-finding tour for future trips than an actual time of intensive research. Although frustrating, it was good because we learned what to expect as far as government red tape, documents, and permits were concerned. We also learned about weather conditions, campsites, available provisions, and other details that made it possible for us to plan successful future trips."

In 1990 David was awarded another grant by WCI/NYYS, and the Moyers left for a year of research in Tanzania. David, Joyce, and Shera moved into a farm house near the town of Mbeya in southern Tanzania. The research site is 200 miles northeast of Mbeya. Food, equipment, fuel, and supplies all had to be packed in.

During breaks from field work they enjoyed the relative conveniences of living in Mbeya... conveniences such as hot and cold running water, a generator for electricity in the evenings, and the availability of a variety of fresh produce and dairy products.

Joyce had planned to accompany David on all of the research trips, but two months into the project they discovered that their second child was on the way and plans were changed. Joyce accompanied him as long as her pregnancy allowed. After that she and three-year-old Shera remained back in Mbeya while David worked in the forest with two Tanzanian assistants.

"To get the project started and learn the birds we initially netted large numbers of them," David explains. "These were measured, photographed, banded, and released. Very little is known about the habitats and voices of forest birds in this area. Many of them are not even illustrated in any of the standard reference books on East African birds.

"I focused on learning the birds in the hand, and on tape-recording vocalizations and playing them back to draw in and identify the source. In this way I gradually built up the information needed to begin a bird census," David explains.

A typical day would start about one hour before dawn and end between 10 and 11 p.m. It was necessary to begin census work in the forest about 45 minutes before dawn as many species sing only at this time. The census would end around 11 a.m. and they would take several hours off for lunch and camp-related work. Afternoons were spent collecting data in the forest, and evenings were used to write up notes.

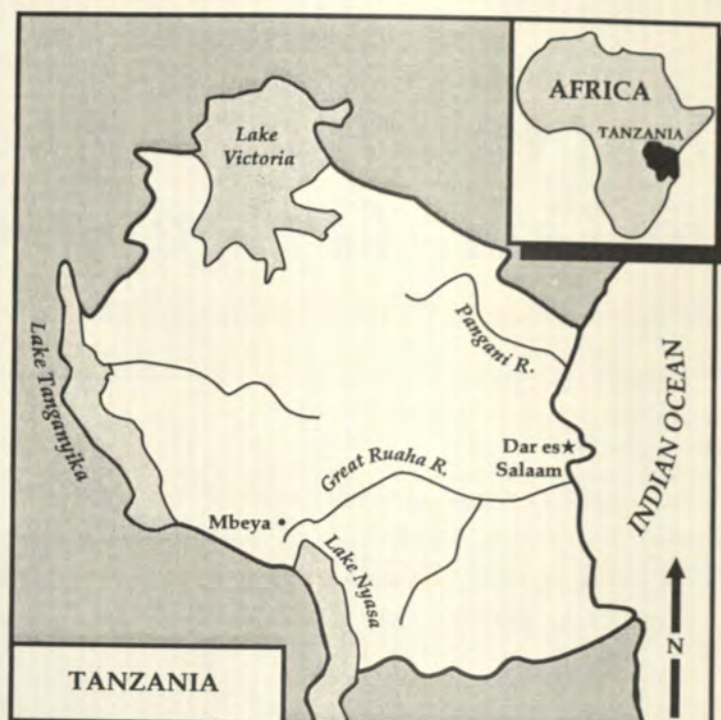
But rain—lots of rain—mechanical problems with his vehicle, and a new baby coming made it difficult to spend as much time in the field as he needed. One entire month, nearing the end of the research project, Joyce traveled to Tatanda and stayed with David's family at the mission while he went out to the field site.

In early March 1991, the Moyers traveled to Nairobi, Kenya, to await the arrival of their new baby. Julia was born on March 16 at Kijabe mission hospital. They returned to Tanzania in April and David finished up his research in July.

Back in the States, David, Joyce and the girls are living in Baton Rouge near Louisiana State University. He is continuing his studies and writing up field data for a theses to complete the requirements for a master's degree at Louisiana State University.

But still the question arises—Why Tanzania?

"The forests of Tanzania are under tremendous pressure both for their supply of valuable timber and for their possibilities for agriculture. The majority of people in Tanzania are subsistence farmers practicing shifting cultivation. They farm a plot of land for several years, and when the soil fertility

declines they move on. In the absence of chemical fertilizers forests are often cut and burned to support this type of agriculture," David explains.

The Tanzanian government has established an extensive system of national parks. However, very little forest is included within these park boundaries at present.

"My objective is to continue research in Tanzanian forests and try to bring about their conservation," David lists three goals for his research: (1) travel throughout the country and generate a list of the forests that need consideration for protection, (2) inventory those forests to identify what species of animals are found there, and (3) draw up a management plan for the forests.

"The future exploitation of these forests must be controlled. Harvesting of valuable hardwoods is sustainable using traditional methods, but clearing a forest for agriculture destroys a forest forever.

"Joyce and I plan to return to Tanzania toward the end of 1992. We will live in Mbeya and I will continue my research on forest birds. Then I plan to enter the PhD program in zoology at the University of Dar es Salaam in Tanzania and finish my education," David says.

In their hearts they also carry another goal.

"We also intend to be support personnel for the missionaries serving there. I will have government contacts and will be able to help with some of the routine official business. We will be able to help them get supplies, since Mbeya is on a main road and it is easier to get things there. Our home will always be open for them to visit, and we will take time to go to their stations and help whenever possible."

Stewardship, conservation, go ye into all the world—David and Joyce Moyer are using their heritage, training, and vision to serve Christ in Tanzania, East Africa.



# Two seminary couples cross newly opened border

May 1991. Grace Theological Seminary held its commencement exercises. Two of the graduates were Rex Durham (also a graduate from Grace College, 1982), who earned his M.A. in Missions and Certificate in Biblical Studies, and Dave Benzel, a graduate of Los Angeles Baptist College, who earned his M.Div. and Th.M. degrees.

Dave and Sharon (Llewellyn, B.A. Grace College, 1979) Benzel were married in 1987 and lived in Winona Lake while Dave completed seminary. Rex and Lori (Meads B.A. Grace College, 1984) married in 1984 and moved back to Winona Lake from their Virginia home in 1988 in order for Rex to pursue a seminary degree.

During those years of study the Durhams and the Benzels lived about one mile apart, yet they did not know each other and could not have predicted how closely their paths would travel.

"Graduation was coming and we began seriously investigating ministry opportunities," Dave Benzel remembers. "I was looking at the bulletin boards downstairs in McClain Hall when I saw a posting encouraging anyone interested in ministry in Russia to contact Send International."

Dave had a long-standing interest in Russia, because his German grandparents had lived in a western section of the country. He wrote for more information.

One thing that surprised him was that he and Sharon were not the only Grace Seminary couples interested in missions in the Soviet Union. "We were amazed to hear in further correspondence with the representatives of Send that we were the second couple to be preparing to go to Russia from Grace, and that the first couple was Rex and Lori. We didn't even know them or about their interest in serving in Eastern Europe."

Rex and Lori had been interested in that mission field for some time. They had been living in Virginia when the founder of Operation Mobilization came to speak at their home church. "Through his influence and enthusiasm we were convinced to go to Europe during the summer of 1986," Rex recalls.

As they worked in Europe, observing foreign missions firsthand, God impressed upon both Rex and Lori the deep need of the people—especially in Eastern Europe. But the door to the east had not yet opened. The iron curtain shrouded the eastern-block countries.

"After we returned home, the personnel director of Operation Mobilization asked us to serve as recruiters for further mission trips. Following those six months recruiting, we traveled to Yugoslavia for the summer then stayed another 14 months working with a team based in Vienna, Austria," Lori says.

Realizing that Rex would need seminary training for full-time missionary service, they moved to Winona Lake, and he began classes in January 1989. Their goal was to prepare for the work, trusting the Lord to open the way. It was during a Grace Conference on Missions that they met representatives of Send International.

In November 1989 the Berlin Wall shuddered and fell under the pounding sledgehammers of freedom as the weakened iron curtain opened for the first time in nearly a half century. The time was characterized by swift and unexpected changes. The door was opening at last.

In preparation for their ministries in Russia, both couples will take part in a new language and cultural studies program at Kiev State University in the Russian Ukraine. The program was established by Dr. Robert Provost, Director of the Central European and Russian Department for Send International, in cooperation with the university and several pastors in Kiev. (Dr. Provost earned his M.Div. degree from Grace Theological Seminary in 1977.)

The program orients missionaries to language, history, economics, politics, and geography through classes and field trips led by Russian instructors. The Durhams and the Benzels will live in Kiev to participate in this course of study. The classes will meet six hours a day, six days a week. The entire course will last 11 months.

"After the language study we are hopeful that it will be clear where God wants us to locate," explains Sharon Benzel. Dave adds: "The leaders for the Ukrainian churches are in Kiev, and we are expecting that after they observe us and see our particular strengths and abilities, they will guide us to the position where we could most effectively serve." Dave expects to work with pastors, reinforcing their understanding of how to study and handle the Scriptures. He also hopes to train them to be more effective leaders of their congregations.

"When we know what our situation will be, then we will come back and focus on our necessary financial support."

While at the University both couples will have the chance to meet young Russians who speak both Russian and English. "This will provide great opportunities for conversations and beginning relationships long before we are fluent in conversational Russian," says Lori.

"I like to talk with young people," Rex adds, "and Russian youth are so interested in Americans that they will often initiate the conversations. They will spend a great deal of time talking and asking many questions. Some are so bold as to ask 'What do you think of God?' or 'What do you believe about Jesus?' providing unexpectedly easy opportunities to discuss God and His word."

Rex and Lori also plan to return to the United States after their 11 months of training in Kiev. "We plan to come back for as brief a time as possible to raise our support, then return for a full term of missionary service. Our experiences with the Russian people have given us a great desire to live there and work with them," Rex says.

"The Russian people are such wonderful people who have such a spiritual hunger. We wonder if the hunger might not even be deeper than we entirely realize. They are calling us, requesting that we come and give them help. But we fear the window of opportunity for evangelism in Russia may only remain open for a very short time. The current political and economic instability may slam it shut—we've got to get in there now."

men here have few or no accomplishments in their lives," he points out. "But, when a man is given this kind of opportunity and can gradually move into a position of accomplishment and success, his attitudes change dramatically. I've watched their confidence levels and self-esteem rise.

"The men who come from Grace to teach have such deep desires to share what they have and what they believe. Their attitudes have had such a positive influence on the inmates."

And now, six years after the men asked those penetrating

questions—"Why not you? Why not Grace?"—Ken's desire for discipling and educating men in prison continues to expand. "My dream now goes beyond Grace College and ISP. I think Prison Fellowship should be approaching Christian colleges all across the country to start similar programs at their local prisons.

"I want our Christian brothers who are in prison to be better grounded in the Word of God, to feel better about themselves, to have something to show for their time in prison; to be equipped to live effectively for Christ.

"It is time we considered what we will do with our Christian brothers who are in prison. Christ offered them forgiveness . . . what then do we offer?"
